State of Iowa, Madison County, SS:

I Samuel H. Boling of the County and State aforesaid, being of lawful age on my oath depose and say that I am a resident of Madison County, Iowa and have been for many years last past. That I was personally acquainted with Elizabeth Jane Bullock, grantee in a certain warranty deed dated April 2nd, 1858, conveying the SW 1/4 Sec. 22-74-28, Madison County, Iowa, and recorded in deed Record H page 59 of said county; that she was the same and identical person as the Elizabeth Robinson who with her husband B.H. or Benjamin H. Robinson were grantors in a certain warranty deed dated February 26th., 1869, conveying the above described real estate and recorded in Deed Record No. 2 page 18 of said county, the said Elizabeth Jane Bullock having intermarried with B.H. or Benjamin H. Robinson. That I was well acquainted with the firm of McCaughan and Dabney who were grantors in a certain Quit claim deed dated May 5th., 1873, conveying the above described real estate and recorded in Deed Record 8 page 235 of said County. That the said firm of McCaughan and Dabney was composed of J.S. McCaughan and A.R. Dabney and no other person. That J.S. McCaughan, America McCaughan and A.R. Dabney were grantors in a certain warranty deed dated June 16th., 1873, conveying the above described real estate and recorded in Deed Record 8 page 372 of said county and that J.S. McCaughan and America McCaughan were husband and wife and A.R. Dabney was a single and unmarried man on the said date. That Samuel H. Boling who was the grantee in the last mentioned deed was the same person as S.H. Boling who was grantor in a certain warranty deed dated May 20th 1874, conveying the above described real estate and recorded in Deed Record 9 page 390 of said county and the Samuel H. Boling who was grantee in a certain warranty deed dated September 11th 1875 conveying the above described land and recorded in Deed Record 11 page 371 of said county and the S.H. Boling who with his wife, Sarah Boling were grantors in a certain warranty deed conveying the above described land dated October 1st 1881, and recorded in Deed Record 19 page 529 of said county and the S.H. Boling who was grantee in a certain warranty deed dated September 8th 1883, conveying the above described real estate and recorded in Deed Record 23 page 340 of said county and the S.H. Boling who with his wife Sarah E. Boling were grantors in a certain warranty deed dated January 21st 1884, conveying the above described land and recorded in Deed Record 27 page 442, was the same and identical man, viz myself. That wherever the name of Samuel H. Boling Samuel H. Boling or S.H. Boling appears in the title to the above described real estate the same person is meant, viz: Samuel H. Boling. That I was well and personally acquainted with John D. Bullock who was grantee in a certain warranty deed dated May 20th., 1874, conveying the above described real estate and recorded in Deed Record 9 page 390 of said county and that he was the same and identical person as J.D. Bullock who with his wife, Lucy A. Bullock were grantors in a certain warranty deed dated September 11th 1875, conveying the above described real estate and
