Articles of Incorporation) The persons whose names are subscribed herete and all The Winterset Cometry other persons who may hereafter subscribe their names hereto do hereby associate themselves together as a body corporate to organize and create a corporation under Chapter 2 of Title IX of the Code of Iowa and adopt the following Articles of Incorporation for the Government of such corporation.

The name of this corporation shall be the "Winterset Cometry Improvement Associations and its place of business shall be at Winterset, in Madison County, Iowa.
II- The purpose and object for which this corporation is formed is the cire, improve-II- The purpose and object for which this corporation is formed is the cire, improvement and adormment of the Cemetry at Winterset, Iowa, and to act as Trustee under the provisions of Chapter SA of Title III, of the Code of Iowa, and to execute any trust committed to it by any individuals in relation to said Cemetry; and to have the care management and control of the Cemetry in so far as the same may be committed to this Association by the City of Winterset, Iowa, And to receive contributions for the improvement additadornment of the Cemetry and to expend the same for such purposes. III- The officers of this Association shall be a President, Vice-President, Secretary Treasurer and Three Directors, and the duties of the officers shall be such as usually pertain to the offices held by them.

IV- Any person may become a member of this Association by signing these Articles of Incorporation and paying a membership fee of \$1.00; and hereafter any person may become a member of this Association by paying the annual membership fee of One Dollar (\$1.00) without signing these Articles of Incorporation.

V- Each member of this Assiciation shall pay each year to this Association the annual dues of One Dollar (\$1.00) which dues shall be payable on or before March 1st, of each

year hereafter.
VI- The officers of this Assiciation shall be elected at an annual meeting of the Association to be held on the first Monday in February of each year and until the first Association to be held on the first Monday in February of each year and until the first annual meeting J.W.
