State of Ohio Jefferson County SS:

I, Addison C. Lewis, on oath being duly sworn, depose and saith, that Isaac Lewis, late of Jefferson County, and State of Ohio, died on the 16th day of September, 1887, intestate, and left surviving him as his sole heirs at law the following named persons, to-wit:- Eliza A. Lewis, his widow, who died, without re-marrying, on the 29th day of January, 1906; the undersigned Addison C. Lewis, William F. Lewis, and Plummer P. Lewis, all of the County of Jefferson, and State of Ohio, and Anna E. Kaminsky who is a daughter of said decedents, and who is the widow of Charles E. Kaminsky, deceased, of the County of Wayne, and State of Indiana, who are the sole surviving children of Isaac Lewis, deceased, and John McClave who was the husband, (- re-married again in June, 1909) of Elizabeth McClave who is the deceased daughter of said Isaac Lewis, deceased, Roy L. McClave being the sole heir at law of Elizabeth McClave, deceased, the said Elizabeth McClave having died intestate and the said Roy L. McClave being unmarried, until May, 1909, and grandson of said Isaac Lewis, deceased, aforesaid; that Mollie Lewis is the wife of the said William F. Lewis, above named, and Edith Lewis is the wife of Plummer P. Lewis, above named, and Addison C. Lewis, the undersigned, is a widower. That on the 26th day of September, 1887, Letters of Administration were issued out of the Probate Court of Jefferson County, Ohio, upon the estate of said Isaac Lewis, deceased, above named; that the undersigned is and was personally acquainted with all his affairs, and that his estate was fully settled, and his debts all fully paid and discharged; that the said Elizabeth McClave, above mentioned, died intestate on or about the 9 day of February A.D. 1898, and that there was no administration upon her estate, and that said estate was fully settled out of Court and her debts fully paid and discharged. Affiant says that he was on the 26th day of February, 1906, appointed by the Probate Court of Jefferson County, Ohio, Administrator of the Estate of Eliza A. Lewis, deceased, and that all of her debts have been fully paid and satisfied. Affiant further says that the decedent Isaac Lewis at the time of his death was the owner in fee simple of the following described real estate, to-wit:- The West half of the Southwest Quarter, and the West half of the Northwest Quarter of Section Fifteen (15), in Township Seventy four (74) North, and of range twenty-eight (28) west of the fifth P.M. in Madison County, State of Iowa, the northeast quarter of Section fourteen (14), in Township eighty one (81) North, of Range forty-two (42) West of the fifth P.M. in Harrison County, State of Iowa, the northeast quarter of section twenty-four (24) in township one (1) range twelve (12) in Nemaha County, State of Kansas. Further deponent saith not.
