I, Fred Kukuk, of said State and County first being duly sworn upon my oath depose and say that I am the present owner of the NE $\frac{1}{4}$ SE $\frac{1}{4}$ 21-74-28 and that I have been in possession of said land since May 27th, 1876 and have used and occupied the same since that date and have had and held actual, open, notorious and undisputed possession thereof since said May 27th, 1876 and that my title thereto has never been disputed or questioned and I further depose and say that I have had and held actual open and undisputed possession of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ 21-74-28 for more than 10 years last past and that to my personal knowledge Davis Miles never had title to said NE $\frac{1}{4}$ SW $\frac{1}{4}$ 21-74-28 or any part thereof and never claimed title thereto and was never in possession thereof and no one except myself and my grantors have had or claimed title to said land and further that Jacob Ruffner to whom Davis Miles conveyed the N $\frac{1}{2}$ SW $\frac{1}{4}$ 21-74-28 on September 8th, 1855 never had possession of said NE $\frac{1}{4}$ SW $\frac{1}{4}$ 21-74-28 and as a matter of fact the said Davis Miles intended to convey the N $\frac{1}{2}$ NW $\frac{1}{4}$ 21-74-28 and did convey the said N $\frac{1}{2}$ NW $\frac{1}{4}$ 21-74-28 to said Jacob Ruffner who took possession thereof under said deed and

never claimed title to the NE $\frac{1}{4}$ SW $\frac{1}{4}$ 21-74-28 and I further depose and say that I am the same and identical person who executed a mortgage to Peter Leffler on the NE $\frac{1}{4}$ SE $\frac{1}{4}$ 21-74-28 on May 27th, 1876 and that I paid the note secured thereby and received the same to-gether with mortgage securing it and the said Peter Leffler has never claimed that said note was not paid and fully satisfied, and further that he was alive on February 21st, 1893, and I was personally acquainted with G.W. Devin who conveyed E $\frac{1}{2}$ NW $\frac{1}{4}$ 28-74-28 to Geo F. Weeks and that his proper name was Geo W. Devin.
