Arnold who died intestate on or about April 7th, 1874 seized in fee of the SE 1/4 NE 1/4 31-76-26 and I well and personally know that Maria Arnold who is given as the widow of said decedent in the registry of heirs filed in his estate is the same and identical person as Mariah Arnold to whom James Arnold conveyed his interest in said SE 1/4 NE 1/4 31-76-26 on February 19th 1889 and the same and identical person as Mariah Arnold to whom G.W. Arnold and wife and John W. Arnold and wife conveyed their interest in said land on December 1st, 1893, and I further depose and say that I well and personally know that John Arnold who is given as one of the heirs at law of Samuel B. Arnold, deceased, in the registry of heirs filed in his estate is the same and identical person as John W. Arnold who on December 1st, 1893 conveyed all his interest in the SE 1/4 NE 1/4 31-76-26 to Mariah Arnold, and I further depose and say that I well and personally know that Martha Arnold who is given as one of the heirs at law of Samuel B. Arnold, deceased, in the registry of heirs filed in his estate is the same and identical person as Martha Rolston who together with L.W. Rolston conveyed the undivided 1/8 of the undivided 2/3 of the SE 1/4 NE 1/4 31-76-26 to Maria Arnold on January 17th 1882, she having intermarried with one L.W. Arnold, deceased, in the registry of heirs filed in his estate is the same and identical person as Nettie Rolston who together with her husband Chas. A. Rolston conveyed the undivided 1/8 of 2/3 of the SE 1/4 NE 1/4 31-76-26 to John Arnold on July

Arnold who on October 4th, 1892 conveyed 10 acres of the undivided 2/3 of the W 1/2 NW 1/4 & NW 1/4 SW 1/4 (32) & SE 1/4 NE 1/4 & NE 1/4 SE 1/4 31-76-26 to George W. Arnold who on December 1st, 1893 conveyed my interest in the SE 1/4 NE 1/4 31-76-26 to Mariah Arnold and the same and identical person as George Arnold whose name appears in the registry of heirs filed -- the estate of said Samuel B. Arnold, deceased, George Arnold, G.W. Arnold and George W. Arnold representing one and the same and identical person, and I further depose and say that I am well and personally acquainted with Mrs L.L. Crawford to whom W. W. Pace gave a mortgage on the SE 1/4 NE 1/4 31-76-26 on February 21st 1902 securing the payment of \$1200.00 February 21st 1903, and I well and personally know that the said Mrs L.L.
