I, Porter Rollstin, of lawful age, being first duly sworn, on my oath depose and say, that I was well and personally acquainted with Benjamin James, to whom was patented the SW $\frac{1}{4}$  NW $\frac{1}{4}$  23-75-27, under date of June 10th 1856, and with Benjamin James Jr who with his wife conveyed the above described real estate together with other land June 14th 1856, to one John Struthers, and that the said Benjamin James and Benjamin James Jr. are one and the same identical person. That I was also well and personally acquainted with William McConnelee, who under the name of William McConly acquired title to the NE $\frac{1}{4}$  NE $\frac{1}{4}$  22 and W $\frac{1}{2}$  NW $\frac{1}{4}$  23 all 75-27, and other real estate, under date of February 23rd. 1857, and who conveyed the above described land to Theodore Rudeman on April 20th 1867, and that the said William McConly and the said William McConnelee were one and the same identical person and that his true name is William McConnelee. That I was well acquainted with John S. Holmes in his lifetime and with his family during his lifetime and since his death, that the Roselba Talbot named in the registry of heirs in his estate is the same person as the Roselba Talbot who conveyed her und.  $\frac{1}{10}$  interest in the E $\frac{1}{2}$  NE $\frac{1}{4}$  22 & W $\frac{1}{2}$  W $\frac{1}{2}$  NW $\frac{1}{4}$  23-75-27 and other real estate, April 24-1885 That Jacob N. Holmes named in said Registry of heirs was the same person as the J.N. Holmes who conveyed as heir at law his interest and the interest acquired through Roselba Talbot, in the above described real estate, on February 23rd. 1886. That John W. Holmes named in said Registry of heirs, was the same person as the J.W. Holmes who on August 30th 1887, conveyed his interest in said real estate and also on Sept 1st 1887, That Michael B. Holmes named in said Registry was the same person as the M.B. Holmes who on March 12th. 1886 conveyed his interest in the above described real estate; That Nancy A. Leddy named in said Registry was the same person as the Angeline Leddy who on June 23rd 1886 conveyed her interest in the real estate above described. That Novilla Holmes named in said Registry was the same person as the Novillia Holmes who on June 23rd 1886 acquired Title to said real estate from said Angeline Leddy. That Salmon M. Holmes named in said Registry was the same person as the S.M. Holmes who on Aug 30th and sept 1st 1887 conveyed his interest in the real estate above described. That Ellsworth G. Holmes named in said Registry was the same person as the E.G. Holmes who with his wife (Laura B) Conveyed the above described real estate, on October 7th 1899 to J.N. Holmes. That the Captola Holmes named in the Will of J.N. Holmes as the wife of Testator and the Captola B. Holmes named in the Registry of heirs is one and the same person, to-wit: Captola B. Holmes. That Frank Holmes named in the said Registry of heirs of J.N. Holmes deceased, and the F.A. Holmes who on Dec 29th 1904 assigned his interest in said estate to L.C. Holmes, are one and the same person. That Lester Holmes named in said Registry of heirs and L.C. Holmes who on Dec 29th 1904 acquired the interest of Frank or F.A. Holmes in said estate under the Will, and the L.C. Holmes who on March 28th. 1907 acquired the interest of Walter Holmes under the said Will, are one and the same person. That Walter Holmes named in said Registry should be Walter T. Holmes which is his true name, and that Elmer Holmes named in said Registry should be Elmer M. Holmes which is his true name, and that Ella Holmes named in said Registry is the same person as Ella Holmes Smith, she having intermarried with one Ross Smith who is now deceased, and that her true name is Ella M. Smith, the above facts are stated from my own personal knowledge and an acquaintance of long standing, with the above described persons and facts, having resided in the immediate neighborhood for a great many years. And further deponent sayeth not.,
