I, Geo D. Tower, being first duly sworn on oath depose and state that I am a resident of the County aforesaid, of lawful age and competent to convey; that I am a grandson of George Tower, deceased, late of Troy Grove Township, LaSalle County, Illinois, who departed this life on or about Oct. 1, 1864, the said George Tower being the grantee in the certain warranty deed executed by William A. Golden, dated Feb 10, 1860 and filed for record on March 2, 1860 in the Recorders office of Madison County, Iowa, and there recorded in Book "K" on page 92, conveying the SE $\frac{1}{4}$  of Section 13 in Twp. 74 North, range 26 West of the 5th P.M. in Iowa, that the said George Tower left surviving him Mary Ann Tower his widow, and Justus D. Tower, Augustus C. Tower and Daniel Tower, his only sons at the time of his decease, and Jerusha Tower otherwise known as Mary J. Tower and Caroline E. Tower were the only daughters of said George Tower at the time of his decease, and that the said Mary Ann Tower was the mother of all of said sons and daughters; that the said Daniel Tower died intestate, unmarried and without issue leaving surviving him as his only heir his mother the said Mary Ann Tower; that after the death of the said George Tower the said Jerusha Tower otherwise known as Mary J. Tower married one Samuel B. Dix who survived his said wife and thereafter executed the certain Quit Claim Deed to Augustus C. Tower, Justus D. Tower and Carrie E. Blanchard, dated Feb 28, 1878 and filed for record on March 2, 1878 in said Recorder's office and there recorded in Book 15 on page 189 conveying the premises above described; that Carrie E. Blanchard named as one of the grantees in the said Quit Claim Deed is one and the same and identical person as Caroline E. Blanchard one of the grantors in the certain warranty deed executed by Justus D. Tower and wife, A.C. Tower and wife, Caroline E. Blanchard and husband and Mary Ann Tower (widow) to RALPH J. Foster, dated October 17, 1879 and filed for record on Nov 15, 1879 in said Recorder's office and there recorded in Book 15 on page 424 conveying said premises, and the said Caroline E. Tower is also one and the same and identical person as the said Caroline E. Blanchard and further deponent saith not.
