STIPUDATION. Exhibit "A". WHEREAS, S.D. Alexander is the owner of the West Half of Section Thirty-two (32), and that portion of the East Half of Section Thirty-one (31) lying between the right of way of the Chicago, Rock Island and Pacific Reilway Company and the public highway running East and West through said Half Section, all in Township Seventy-six (76) North, of East and West through said Half Section, all in Township Seventy-six (76) North, of Range Twenty-seven (27), West of the 5th P.M., Iowa, and also the North West Quarter and the West Half of the North West Quarter of the South West Quarter of Section Five (5) in Township Seventy-five (75) North, of Range Twenty-seven (27), West of the 5th P.M., Iowa, and WHEREAS, L.M. Alexander is the owner of all that part of the East Half of said Section Thirty-one (31) not owned by the said S.D. Alexander and the said Railway Company, and also all that portion of Section Six (6) in Township Seventy-five (75) North, of Range Twenty-seven (27), West 5th P.M. Iowa, lying North of Middle River abutting upon the East line of said Section, and WHEREAS, The Section line between Sections Thirty-one and Thirty-two in Township 76, North, of Range 27, and between Sections 5 and 6 in Township 75 North, of Range 27, West 5th P.M. Iowa, and the corner stones by which said lines or corners are determined are lost, destroyed and in dispute. NOW THEREFORE, It is hereby agreed by and between the parties hereto that Frank McNutt stones by which said lines or corners are determined are 103t, destroyed and in dispute.
NOW THEREPORE, It is hereby agreed by and between the parties hereto that Frank McNutt
County Surveyor of Polk County, Iowa, shall locate and re-establish that portion of
the Section line between said Sections 5 and 6 lying North of Middle River, and that
portion of the Section line between said Sections 31 and 32 lying North of the said
right of way of the said Railway Company, and also that portion of the said section
line lying South of the highway running East and West through said lands; and the said
Surveyor shall erect a stone or other visible monument on the said lines so established by him at each of the following corners, to-wit: One at the North West Corner of said Section 32, and one at the South West Corner of the North West Quarter of said Section 32, and one at the intersection of said West line of said Section 32 with the North line of the right of way of said Railway Company, and one at the intersection of said Section line with the South line of the public highway running East and West through the West Half of said Section 32, and one at the North West Corner of said Section 5, and one —the North Bank of Middle River on the West line of said Section 5, and one at the South West Corner of the North West Quarter of the South West Quarter of said Section 5: and said Surveyor shall also cause temporary stakes to be set along the said Section 5: and said Surveyor shall also cause temporary states to be set along the said Section lines between the monuments above mentioned at convenient distances to enable said lines to be located by the parties desiring to erect a fence thereon. It is further agreed that the said Surveyor shall attach his report of said survey to this agreement and that the same shall be filed in the office of the Recorder of Madison County, Iowa, and duly recorded, and the line so established by said surveyor shall be taken and accepted by the parties hereto as the true boundry lines between their said lands. And it is further agreed that each of the parties hereto are to pay one half of the expenses of establishing said lines. It is further agreed that the fence to be built and run between the said lands of the parties which will run from the public highway running East and West through said Sections 31 & 32, South on the Section public highway running East and West through said Sections 31 & 32, South on the Section between said Sections 31 & 32 and said Sections 5 & 6, shall be by the said Surveyor divided in to four divisions or parts of equal length, and the North one fourth to be erected and maintained by L.M. Alexander, and the next division to the South to be erected and maintained by S.D. Alexander, and the next division South by L.M. Alexander, and the next division South by L.M.
