 That I am well and personally acquainted with the persons whose names are hereinafter
 mentioned, and of my own personal knowledge know the facts as herein set forth.
 That the M.J. Peggs, named in the registry of Heirs filed in the estate of said J.P.
 Ford deceased, and the Martha J. Peggs, who on February 16th 1870, conveyed the undivided
 One-sixth of Lot 5 Block 9 of West Addition to Winterset, Iowa, and other property, to
 I.S. Ford, as shown by deed recorded in Deed Record 2 page 289 of the records of Madi-
 son County, Iowa, is one and the same identical person.
 That the I.S. Ford named in said Registry of Heirs; the I.S. Ford named as grantee in
 deed recorded in Deed Record 2 page 166 of said records; the I.S. Ford named as grantee
 in deed recorded in Deed Record 2 page 289 of said records; the I.S. Ford named as
 granted in deed recorded in Deed Record 2 page 435 of said records; the Ivin S. Ford Sr
 named as grantee in deed recorded in Deed Record 6 page 466 of said records; the Ivin S.
 Ford Sen., named as grantee in deed recorded in Deed Record 8 page 14 of said records,
 and the I.S. Ford named as one of the grantors in deed recorded in Deed Record 6 page
 504 of said records, are all one and the same identical person.
 That the Eliza A. Rolan, named in said Registry of Heirs, and the E.A. Roland who with
 her husband C.W. Roland on Oct. 23rd 1869, conveyed the above described property to I.S.
 Ford as shown by deed recorded in Deed Record 2 page 166 of said records, is one and
 the same identical person, her correct name being Eliza A. Roland.
 That the Malissa A. Kittleman, named in said Registry of Heirs, and the Melissa A.
 Kettleman who with her husband W.W. Kettleman on June 29th 1870, conveyed the above des-
 cribed property to I. S. Ford as shown by deed recorded in Deed Record 2 page 435 of
 said records, is one and the same identical person, her correct name being Melissa A.
 Kettleman. That the I.S. Ford named in said Registry of Heirs as an heir of J.E. Ford
 deceased, who was a son of said J.P. Ford deceased, and the Ivin S. Ford Jr. named as
 one of the grantors in deed recorded in Deed Record 6 page 466 of said records, is one
 and the same identical person. That the B.C. Ford, C.B. Ford and Melissa A. Ford, named
 in said Registry of Heirs as grandchildren of the said J.P. Ford deceased, are the same
 and identical persons as the Becks C. Ford, Cora B. Ford and Malissa A. Ford respectively,
 named in the Guardianship proceedings and in the Guardian's Deed in Deed Record 8 page
 14 shown at entries No. 15 and 16 of attached abstract.
 That Elizabeth Ford, widow of J.P. Ford deceased, died about the year 1901 or 1902.
