I, A.J. Lee of said County and State being first duly sworn upon my oath depose and say that I am the same and identical person as the Adoniram J. Lee mentioned in the last will and testament of James M. Lee who died testate in Madison County, Iowa in the year 1897 and that I am a son of the said James M. Lee. That I am the same and identical person as Judson A. Lee mentioned in the registry of heirs of the said James M. Lee as shown by the records of Madison County, Iowa and that I am the same and identical person as Adonrian J. Lee mentioned in the registry of heirs of Elenor Lee who died intestate in Madison County, Iowa on or about January 1st 1902 and that the said Elenor Lee was my mother. That I am the same and identical person as Judson A. Lee named as defendant in the partition suit brought on or about November 20th 1902 in the District Court of Madison County, Iowa and that I am the same and identical person as A.J. Lee, grantee in three conveyances each of the South East Quarter ( $\frac{1}{4}$ ) of the South West Quarter ( $\frac{1}{4}$ ) of Section Ten (10) in Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M. Iowa. The grantors in these deeds are Mary P. Shaver, and husband, Benton Steel and wife and Merbie Jones and husband who were three of the heirs at law of William Steel who died in Madison County, Iowa on or about May 9th, 1862 and that I am the same and identical person as A. Jud Lee who on or about April 10th 1904 joined in a conveyance of the North West Quarter ( $\frac{1}{4}$ ) of the South East Quarter ( $\frac{1}{4}$ ) and the South East Quarter ( $\frac{1}{4}$ ) of the South West Quarter ( $\frac{1}{4}$ ) of Section Ten (10), Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M. Iowa to George S. Haynes and that I am the same and identical person as Judson A. Lee named as referee to succeed C.F. Wood in said partition suit hereinbefore referred to, That in the proceedings in the settlement of the estates of the said James M. Lee and Elenor Lee and in the partition suit hereinbefore referred to the name J.B. Lee refers to and is the same person as Jesse B. Lee, That W.T. Lee refers to and is the same person as William T. Lee. That George Lee refers to and is the same person as George J. Lee and Joseph Lee refers to and is the same person as Joseph H. Lee. That Nettie B. Schoonover refers to and is the same person as Nettie E. Schoonover. That Rosa Haag, Rosa M. Haag Rosa M. Hegg and Rosa M. Hegg refers to and is the same person. That all of the parties herein named are my brothers and sisters and that the facts herein stated are true as I believe.
