State of Iowa, Madison County, SS:

I, J.R. Thomson, being duly sworn on my oath do depose and say that I was personally well acquainted with the David Beezley, or David L. Beezley one and the same, to whom Bennett Stanley, under date of October 30, 1872, conveyed the Northwest Quarter of the Southeast Quarter, of Section 3, in Township 77 North, Range 28 West of the 5th P.M. in Madison County, Iowa, except certain parts thereof before time deeded to the Chicago, Rock Island & Pacific Railroad Company, and if the name of the grantee in said deed appears as David Beasley, that it is an error in the writing of the same in said deed, or in the recording of the same: the name of the party to whom said land, in fact, was conveyed under said deed, being David Beezley; and further, I know him to be identical with the David Beezley, grantee in a certain warranty deed from the Chicago, Rock Island & Pacific Railroad Company, executed under date of January 13, 1875 conveying to him the said Northeast Quarter of the Southeast Quarter of said Section 3, subject to certain reservations and restrictions therein made; also, I know him to be identical with the D.L. Beezley, one of the grantors in a certain quit claim deed executed under date of January 12, 1889, conveying to one M.D. Hill that part of the North Half of the Southeast Quarter of said Section 3, in said Township and range, lying North of the right of way of the Chicago, Rock Island and Pacific Railroad Company, and I know that the said David Beasley, David Beezley, and D.L. Beezley refer to one and the same person, to-wit, David L. Beezley. I further depose and say that I was personally well acquainted with the Richard B. Mendenhall, grantee in a certain warranty deed from the said David L. Beezley and wife, of date November 11, 1877, wherein certain lands in the North Half of the Southeast Quarter of said Section 3, in Township 77 North, Range 28 West of the 5th P.M. in Madison County, Iowa, was conveyed to the said Richard B. Mendenhall; also, I was personally well acquainted with the R.B. Mendenhall; one of the grantors in a certain warranty deed executed to one William R. Thompson, as grantee, which said deed is shown to be recorded on page 563 of Book 20, of the deed records of the said Madison County, Iowa; also I was personally well acquainted with the Richard B. Mendenhall, one of the grantors in a certain Warranty deed of date January 27, 1883, and shown to be recorded on page 599 of Book 20, of the deed records of the said Madison County, Iowa, and also that I was personally well acquainted with the R.B. Mendenhall, one of the grantors in a certain warranty deed of date February 2, 1888, conveying certain real estate therein described to one M.D. Hill, as grantee, and I know that the said Richard B. Mendenhall and R.B. Mendenhall, in each and every instance referred to one and the same person, to-wit Richard B. Mendenhall. All of which is true as I verily believe.
