I, H.L. Bousquet, being first duly sworn, depose and say that I am a resident of Marion County, Iowa, that the facts herein set out are based on my personal knowledge and acquaintance with the persons named, and that I have no interest in making this affidavit except to establish a record of the facts herein stated. That the B.F. Keables who is named as grantee in a certain deed from John A. Pitzer and wife, dated September 3rd, 1857, recorded in Deed Record E page 437 of Madison County, Iowa, and conveying Lot Two in Block Seven of Pitzer & Knights Addition to the City of Winterset, Iowa, the B. F. Koble who redeemed said land from tax sale as is shown by Tax Sale Book 1 page 222 of Madison County, Iowa, and the B.F. Keables who redeemed said land from tax sale as is shown by Tax Sale Book 3 page 28 of said County, is one and the same person, his correct name being B.F. Keables. That the Henry P. Scholts named in the certificate of administration made by A.C. Bussey Clerk of the District Court of Marion County, Iowa, and recorded in Miscellaneous Record Book 12 page 176 of Madison County, Ia, the Henry P. Scholts who is named as mortgagee in the record of a certain mortgage made by B.F. Keables and wife, dated November 8<sup>th</sup> 1859, and recorded in Deed Record B page 533 of Madison County, Iowa, and the H.P. Scholts whose name so appears in the marginal release on the record of said mortgage is one and the same person his true and full name being Henry P. Scholte, and that he is also the same person as the Henry P. Scholts named as decedent in the record of a certain power of attorney executed by Egbert Winter as administrator to John M. Cooper, dated February 6<sup>th</sup> 1859, and recorded in Miscellaneous Record Book 1 page 22 of Madison County, Iowa. That the Egbert Winter who is named in the Power of attorney last above described herein as administrator of the estate of the said Henry P. Scholte, the E. Winter who as administrator by his attorney executed the marginal release of mortgage herein above referred as shown by the record of the same, and the Egbert Winters who is named in the said certificate of administration above herein referred to and recorded in Miscellaneous Record Book 12 page 176 of Madison County, Iowa, is one and the same person, his true and correct name being Egbert Winter.
