I, J.M. Lee, being first duly sworn on my oath depose and say that I was well and personally acquainted with Orlando W. Barker and wife Lucy Barker who conveyed the NW 1/4 6-74-29, to John A. Jennings by deed dated December 19th, 1864 and recorded in Record "O" at page 468 thereof, and that the said Lucy Barker died prior to the death of her husband, the said Orlando W. Barker.

I further depose and say that the E.C. Stewart who conveyed said real estate to I.W. Brownell by Deed dated May 29th, 1871, and recorded in Deed Record 7, page 173 was, at the time of making said conveyance, a married man, his wife being the Mary A. Johnson (formerly Stewart), who together with W.B. Johnson conveyed said real estate to Almon H. Farnsworth by deed dated June 23rd, 1880, and recorded in Deed Record 15 at page 581 thereof and that the said E.C. Stewart and the said Mary A. Johnson, (formerly Stewart), were the same persons as the E.C. Stewart and Mary A. Stewart whose decree of divorce is shown in District Court Journal "C", page-----.

I further depose and say that the I.W. Brownell who was grantee in said conveyance from E.C. Stewart was the same person as the Ira W. Brownell, who with his wife conveyed said real estate to Almon H. Farnsworth by deed dated January 6th, 1873 and recorded in Deed Record 7 page 168. I further depose and say that the Bertha M. Osborn, one of the grantees in a deed from A.H. and Laura B. Farnsworth dated July 22th, 1880, and recorded in Deed Record 26, page 456 is the same person as the Bertha M. Osborn, who with her husband afterward conveyed her interest in said real estate to W.E. Brownell by deed dated February 20th, 1904 and recorded in Deed Record 39, page 253 and that Almon F. Brownell another grantor in said deed from A.H. and Laura B. Farnsworth is the same person as the A.F. Brownell who with his wife conveyed his interest in said real estate to W.E. Brownell by deed dated September 8th, 1906, and recorded in Deed Record 34, page 432 and that the Wilford E. Brownell, named as grantee in the above mentioned deed, from A.H. and Laura B. Farnsworth is the same person as the W.E. Brownell, named

in said above mentioned deeds from Bertha M. Orsborn and A.F. Brownell.
I further depose and say that the Lewis Platt to whom W.E. Brownell executed a mortgage on said land, dated February 6th, 1905, and recorded in Mortgage Record 36, page 221, is the same person as the Louis Platt who executed a marginal release of said mortgage, dated December 27th, 1905.
