I, Esra Brownell of said County, and State, being sworn depose and say that I am the Esra Brownell who formerly owned the South East Quarter of Section 23 and West Half of the South West Quarter of Section 24, all in Township 75 North, Range 28 West of the 5th P.M. Iowa, and I am the mortgagor named in the mortgage recorded in Mortgage Record 5 on page 552 of the Records of Madison County, Iowa. That said mortgage has long since been paid in full and the same and the notes secured thereby were surrendered to me and cancelled. That the mortgage Recorded in Mortgage Record 24 at Page 400 of the Records of Madison County, Iowa, was executed by me and my wife to Willard F. Myrick. That he is the same identical person as the William F. Myrick who is named in the release of said mortgage, his name having been, in said release erroneously spelled William instead of Willard.
