State of Iowa Madison County SS:

I, H.F. Cunningham, of said County and State, on oath say that I am the H.F. Cunningham who purchased from R.L. Huston referees the east forty six and one half acres of the north half of the north east quarter of section twenty one (21) Township Seventy-five (75), Range Twenty nine (29), West of 5th P.M., Iowa, and that I am the same man, who under my full name, Highland F. Cunningham, on or about May 4th, 1911, executed a mortgage thereon to Madison County, Iowa, for the use of the school fund. That the Lucy A. Little, who on or about April 19, 1884, executed to my wife Sarah E. Cunningham a deed conveying her interest in the quarter section above referred to, being recorded in deed record twenty three (23), of Madison County, Iowa, at page 522 thereof, was the same person as the Lucy A. Harrison or Lucy Ann Harrison a daughter of John E. Harrison, named as Lucy Ann Harrison in his registry of heirs; and that the Sarah E. Cunningham who at the November Term, 1884, of the District Court of Madison County, Iowa, brought a suit for the partition of said quarter section, was the same person as Sarah E. Harrison named in the registry of heirs of John E. Harrison; that the widow of said John E. Harrison was Mary E. Harrison afterwards married one John B. Wilkinson, and that Mary E. Wilkinson whose name appears in the chain of title to said real estate was the same and identical person as said Mary E. Harrison; that Mattie F. Johnson named in the registry of heirs of Mary E. Wilkinson, and who appears as defendant in the partition suit brought by J.A. Harrison at the December Term, 1910, of the District Court of Madison County, Iowa, against Sarah E. Cunningham et al, for the partition or sale of said land, was the same and identical person as Mattie L. Johnson, as her name appears in the acceptance of service of the notice of such suit; that I am related to all the parties before named, and know of my own personal knowledge that the facts stated are true. That I had no personal acquaintance with Horace Howard who on or about March 3, 1857, conveyed to Alfred H. Kinney the North Half of the Quarter Section before referred to, the deed appearing in deed record "H" of Madison County, Iowa, at page 297 thereof, but that I know of him as a matter of neighborhood history, he belonging to a family that settled in an early day in the neighborhood of said land, and having relatives still living in the community, and that from my general knowledge gained from neighborhood information, and especially from talks with old members of the family who came to the neighborhood with said Horace Howard, I know that he is the same and identical man as the Horace Howard, as his name appears in the entry of said land from the Government, and in the patent therefor.
