I, Angeline Lee, of said County and State, being first duly sworn, do, upon my oath, depose and say:- That I am a daughter of Samuel B. Barker, deceased, formerly of Madison County, Iowa and who died on or about the 26th day of April A.D. 1859, and that myself and all my brothers and sisters, together with their respective wives and husbands, after my father's death joined in, and each signed, a certain written agreement for the division of lands belonging to his estate, which agreement is dated July 19th, 1861 and is recorded in Deed Record "M" at page 271 of the deed records of Madison County, Iowa, and thereafter each, every and all of said persons joined in a quit claim

Deed to Sarah Barker, my mother and widow of the said Samuel B. Barker; deceased, dated September 23rd, 1868, conveying the North East Quarter (NE $\frac{1}{4}$) of the North East Quarter (NE $\frac{1}{4}$) of Section Twenty (20) and the North West Quarter (NW $\frac{1}{4}$) of the North East Quarter (NE $\frac{1}{4}$) and the North East Quarter (NE $\frac{1}{4}$) of the North West Quarter (NW $\frac{1}{4}$) of Section Twenty-one (21) all in Township Seventy-four (74) North, Range Twenty-nine (29) West of the 5th P.M. and which deed is recorded in Deed Record "W" at page 313 of the records of Madison County, Iowa; and I further depose and say that each, every and all of the children and heirs at law of the said Samuel B. Barker, Deceased, together with their respective husbands and wives joined in the execution of and signed each of said instruments and that no other person or persons joined therein. That while there is some differences in the writing and spelling of the names and abbreviations are used in some places and full name in others in the signatures attached to said deed and said agreement and some such discrepancies appear between such signatures and the names written in the granting clause and the acknowledgment of said deed yet in truth and in fact each and all the heirs at law of said Samuel B. Barker, deceased, joined in the execution of and signed said deed and said agreement. That I have no interest to serve in making this affidavit, either direct or indirect, except to establish the facts hereinbefore set out. Further deponent sayeth not.
