That on March 26th, 1910 the said Joanna Matthews made and executed a mortgage on said land to me for the sum of \$1223.15 said mortgage being recorded in Book 49 page 553 of said records, and whereas said mortgage was made subject to mortgages amounting to \$3100.00, being the same \$3100.00 assumed by her in the deed from me, and hereinabove explained.
