State of Iowa County of Madison SS:

I, C. Danforth, of Madison County, Iowa, being first duly sworn upon oath depose and say that I was well and personally acquainted with Martin Schoepflin, the grantee in the deed from C.D. Bevington and wife and J.J. Hutchings and wife dated March 10, 1868, and recorded March 11, 1868, on page 298 of Deed Record V of the records of Madison County, Iowa, conveying the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirty-six (36) in Township Seventy-six (76) North of Range Twenty-nine (29) West of the 5th P.M. Iowa. That about the month of February, 1875, I conducted the negotiations for the conveyance of said real estate by the said Martin Schoepflin to William R. Danforth, and that the Martin Schoepflin named as grantor in the deed to William R. Danforth of date February 26, 1875, recorded February 26, 1875, on page 8 of Deed Record 11 of the records of Madison County, Iowa, conveying the Southeast Quarter (SE $\frac{1}{4}$) of said Section Thirty-six (36) in Township Seventy-six (76) North of Range Twenty-nine (29) West of the 5th P.M. Iowa, is the same person named as Martin Schoepflin in the said deed from C.D. Bevington and J.J. Hutchings above described. I further state that I am a brother of the grantee named William R. Danforth, in the deed dated February 26, 1875, recorded the same day, on page 8 of Deed Record 11 of the records of Madison County, Iowa; and that the person named W.R. Danforth, grantor in the deed of date October 27, 1875, recorded November 1, 1875, on page 467 of Deed Record 11 of the records of Madison County, Iowa, and the W.R. Danforth named as one of the grantees in the deed dated November 14, 1876, recorded the same day, on page 283 of Deed Record 13 of the records of Madison County, Iowa, and the W.R. Danforth named as grantor in the deed dated October 27, 1875, recorded November 1, 1875, on page 463 of Deed Record 11 of the records of Madison County, Iowa, are each and all the same person, being the same William R. Danforth named as grantee in the said conveyance of date February 26, 1875, recorded on page 8 of Deed Record 11 of the records of Madison County, Iowa. The said William R. Danforth and the said W.R. Danforth named in the said various conveyances being one and the same person and he being a brother of mine. I further state that I have no pecuniary interest in this matter and this affidavit is made only for the purpose of identifying the grantees and grantors, in the said respective conveyances.
