I, A.F. Bissell, of the said County do on my oath depose and say that I am well and personally acquainted with Josiah A. Snyder to whom C.D. Bevington and Eliza Bevington, on or about June, 17th, 1873, conveyed the following real estate, situated in Madison County, Iowa, to-wit:-
The North East Quarter ($\frac{1}{4}$) of the North East Quarter ($\frac{1}{4}$) of Section Thirty-two (32) in Township Seventy-seven (77) North, of Range Twenty nine (29), West of the 5th, P.M. Iowa, which deed was filed for record June 17th, 1873, in the office of the Recorder of Madison County Iowa, and recorded in Deed Record Seven (7) on page 495, and that the said Josiah A. Snyder and one, J.A. Snyder, who on or about August 21st, 1876, conveyed the said real estate to O. Bissell, which deed was filed with the Recorder of Madison County, Iowa, on August 23rd, 1876 and recorded in Deed record Thirteen on page 197, were and are the same person, that is, the said Josiah A. Snyder was and is the same person as J.A. Snyder; and that the said O. Bissell and O. B. Bissell who on or about October 14th, 1889, conveyed the said real estate to F.L. Bissell, which deed was filed for record in the office of Recorder of Madison County, Iowa, on the same day and recorded in Deed Record Twenty seven, page 469 were one and the same person; and that Orrin B. Bissell to whom Dormick Gilliam and wife on or about October 7th, 1854, conveyed the South East Quarter ($\frac{1}{4}$) of the South West Quarter ($\frac{1}{4}$) of Section Five (5) Township Seventy six (76), North of Range Twenty nine (29), West of the 5th P.M. Iowa, which deed was filed for record in the office of the Recorder of Madison County, Iowa, on October 24th, A.D. 1854, and recorded in Deed Record "A" on page 473, and O.B. Bissell, who on or about October 14th, 1889, conveyed to Elmer E. Bissell the East Half ($\frac{1}{2}$) of the South East Quarter ($\frac{1}{4}$) of the South West Quarter ($\frac{1}{4}$) of Section Five (5) Township Seventy six (76) North of Range Twenty nine (29) West of the 5th P.M. Iowa, which deed was filed for record on the same day and recorded on deed record Twenty seven page 471 were one and the same person, that is the said O. Bissell, O.B. Bissell, Orrin B. Bissell, and Orrin B. Bissell were one and the same person.
