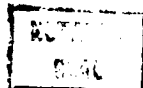

State of Iowa Madison County SS:

I, F.M. Peed, being first duly sworn, on my oath depose and say that I was well acquainted with the persons named herein, and make these statements from personal knowledge. That the Geo. W. Seevers who obtained title to the $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ Sec. 15-76-28 by deed dated July 25th, 1864 and recorded in Record "O", page 89 was the same person as the G.W. Seevers who conveyed said land to Valentine M. Gideon by deed dated September 30th, 1871, and recorded in Deed Record 6, page 499; and that the said Valentine M. Gideon was the same person as the V.M. Gideon who afterwards executed a deed for said land dated June 16th, 1875 and recorded in Deed Record 11, page 285. That the Mathew M. McGee who was grantee in a deed from Noah Sulgrove and wife dated October 14th, 1862 and recorded in Record "M" page 354 was the same person as the M.M. McGee who afterward executed a deed to John D. Whitonack dated January 22nd, 1864 and recorded in Record "K", page 583 and also as the M.M. McGee who executed a deed to John W. Thompson, dated April 20th, 1864 and recorded in Record "K", page 475. That the Asa M. Clements who was grantee in a deed from Burrel T. Woosley and wife, dated May 28th, 1874 and recorded in Deed Record 9, page 355 was the same person as the A.M. Clements who afterward executed a deed to G.T. Clements dated May 29th, 1883 and recorded in Deed Record 23, page 89; and that the G.T. Clements was the same person as the George T. Clements who afterward executed a deed to Isaac J. Lovell, dated January 6th, 1887 and recorded in Deed Record 26, page 557. That the Mary R. Whitonack who was grantee in a deed from John D. Whitepack, dated May 1st, 1900 and recorded in Deed Record 41, page 532 was the same person as the Mary R. Hays who afterward executed a deed to I.J. Lovell, dated December 13th, 1901 and recorded in Deed Record 43, page 87. That the Isaac J. Lovell who was grantee in a deed dated September 25th 1883 and recorded in Deed Record 23, page 482 was the same person as the Isaac J. Lovell who was grantee in deed dated January 6th, 1887 and recorded in Deed Record 26, page 557 and as the I.J. Lovell who was grantee in deed dated December 22nd, 1890 and recorded in Deed Record 35, page 404 and as the I.J. Lovell who was grantee in deed dated December 21st 1901 and recorded in Deed Record 43, page 87 and as the Isaac J. Lovell who was grantor in deed dated February 9th, 1911 and recorded in Deed Record 53 page 249. All of the above named records being of the records of Madison County, Iowa. Further deponent sayeth not.
