Mills grantor in a Warranty Deed executed by himself and Lydia Mills, his wife, dated March 21, 1872, filed for record June 17, 1872 and recorded at page 540 of Deed record 6 in the office of the recorder of Madison County, Iowa, which Deed conveys the Northeast (NE) fractional Quarter of the North East Quarter (NE $\frac{1}{4}$) Section 1-77-29 Madison County, Iowa, and I know that he is one and the same person as Daniel P. Miles who was named as grantee in a certain warranty deed running from Nathan Mendenhall and Mary Ann Mendenhall, said Deed dated November 5, 1869 filed for record April 29, 1871, recorded at page 573 of Deed Record 4 in the office of the recorder of Madison County, Iowa, conveying the East (E) fractional half of the North East Quarter (NE $\frac{1}{4}$) Section 1-77-29 and wherever Daniel P. Mills or Daniel P. Miles appears in connection with the above Real Estate it in each and every instance refers to one and the same person. I further state that I was well and personally acquainted with E.R. Gantt named as Grantee in a Warranty Deed executed by Daniel P. Mills and Lydia Mills, dated May 3, 1871, filed for record March 14, 1872, conveying Forty acres (40) off of the South end of the East Half (E $\frac{1}{2}$) of the North East Quarter (NE $\frac{1}{4}$) Sec. 1-77-29, recorded at page 393 of Deed Record 6 in the office of the Recorder of Madison County, Iowa, and I know that he is one and the same person as E.R. 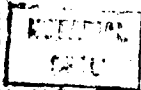

I further state that I was well and personally acquainted with Nathan Mendenhall grantor in a Warranty Deed acknowledged December 15, 1868, filed for record April 8, 1869 recorded at page 545 Deed Record W in the office of the Recorder of Madison County, Iowa, which Deed conveys the following tract of land commencing at the South West (SW) corner of the East Half (E $\frac{1}{2}$) of the North East Quarter (NE $\frac{1}{4}$) of Section 1-77-29 and running thence Eighteen (18) rods North, thence East Eighteen (18) rods, thence South Eighteen (18) rods thence to the place of beginning, and I know that he is one and the same person as N. Mendenhall and wherever the name of Nathan Mendenhall or N. Mendenhall appears in connection with the title to the East Half (E $\frac{1}{2}$) of the North East Quarter (NE $\frac{1}{4}$) Section 1-77-29, it in each and every instance refers to one and the same person. I further state that I was well and personally acquainted with Bonnet Hill grantee in a Warranty Deed dated March 21, 1872, filed for record June 17, 1872, recorded at page 540 Deed record 6 in the office of the recorder of Madison County, Iowa, which Deed conveys the North East (NE)

fractional quarter of the North East Quarter (NE $\frac{1}{4}$) of Section 1-77-29 and I know that he is one and the same person as Benona Hill grantee in a Warranty Deed dated February 24, 1875, filed for record May 5, 1875, recorded at page 153 of Deed Record Eleven (11) in the office of the Recorder of Madison County, Iowa, which Deed conveys the South East Quarter (SE $\frac{1}{4}$) of the North East Quarter (NE $\frac{1}{4}$) of Section 1-77-29, and wherever the name of Benoni Hill or Benona Hill appears in connection with the title to the East Half (E $\frac{1}{2}$) of the North East Quarter (NE $\frac{1}{4}$) Section 1-77-29, it in each and every instance refers to one and the same person. I further state that I was well and personally acquainted with John Williams grantee in a certain Warranty Deed dated April 2, 1883, filed for record August 12, 1884 recorded at page 573 Deed Record 23 in the office of the Madison County Recorder conveying the East Half (E $\frac{1}{2}$) of the North East Quarter (NE $\frac{1}{4}$) of Section 1-77-29 and at the time of the death of the said John Williams he was a widower and unmarried and had been for many years previous. I further state that I was well and personally acquainted with Isiah Williams, son of John Williams referred to above and that he is one and the same person as Isaiah Williams and wherever the name of Isiah Williams or Isaiah Williams appears in connection with the title to the North East Quarter (NE $\frac{1}{4}$) of Section 1-77-29, it in each and every instance refers to one and the same person. I further depose and sayeth not.
