State of Iowa, Madison County SS:

I, Alice A. Myers, a resident of Winterset in said County and State, being first duly sworn on my oath depose and say that to the best of my knowledge and belief Lemuel Kinyoun, patentee of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 31-76-29, and L. Kinyoun, who with Zilphia Kinyoun, conveyed said land, together with other land, to Jacob Myres, by deed dated April 2nd, 1859, represent one and the same person. That I was not personally acquainted with the said Lemuel Kinyoun, but my late husband, Samuel Myers was personally acquainted with him, and I have often heard my said husband during his lifetime talk of the said Lemuel Kinyoun, and I am well convinced and satisfied that the said Lemuel Kinyoun and L. Kinyoun, above referred to, represents the same man.

That Jacob Myres, grantee in said deed from L. Kinyoun and Zilphia Kinyoun, dated April 2nd, 1859, conveying the SE $\frac{1}{4}$ NW $\frac{1}{4}$ & SW $\frac{1}{4}$ NE $\frac{1}{4}$ & N $\frac{1}{2}$ SW $\frac{1}{4}$ Sec. 31-76-29 (and other lands), was the father of said Samuel Myers, my said husband, and that his name is misspelled in said conveyance and should be "Myers" instead of "Myres", and that the said Jacob Myers died in Washington County, Penn., leaving a last will and testament, which was admitted to probate in Madison County, Iowa, as a foreign will, on April 2nd, 1883.

That Hamilton Myers, mentioned in said last will and testament of Jacob Myers, deceased, is the same and identical person as Hamilton B. Myers, who with his wife, Maggie, conveyed the SW $\frac{1}{4}$ NE $\frac{1}{4}$ & SE $\frac{1}{4}$ NW $\frac{1}{4}$ & W FR'L $\frac{1}{2}$ NW $\frac{1}{4}$ & NE $\frac{1}{4}$ SW $\frac{1}{4}$ & 25 acres off the North end of W. Fr'l $\frac{1}{2}$ SW $\frac{1}{4}$ Sec. 31-76-29, to Samuel Myers, by deed dated June 7th, 1882.
