Beezley grantee in a certain Deed dated June 29, 1863, conveying the West Half (W $\frac{1}{2}$ ) of the Northwest Quarter (NW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) Section Twenty-nine (29) and the Southeast Quarter (SE $\frac{1}{4}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) and the Northeast Quarter (NE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) Section Thirty (30) and other real estate, said Deed being recorded in Madison County Iowa records Deed Record "0" page 624; and that David Beezley grantor in a certain Deed dated February 13, 1865 recorded in Madison County, Iowa, records deed record "0" page 591, is one and the same person as David L. Beezley grantee in the above mentioned Deed. I further state that I was well and personally acquainted with Davis Rankin grantee in a certain Deed dated March 12, 1869 recorded in Madison County Iowa records Deed Record 5 page 23, and that David Rankin grantor in a warranty Deed acknowledged March 24, 1873 recorded in Madison County Iowa records, Deed Record 11 page 387, is one and the same person as Davis Rankin grantee in the Deed above mentioned. I further state that I was well and personally acquainted with George W. Cummings grantee in a warranty deed acknowledged March 24, 1873, recorded in Madison County, Iowa, records, deed Record 11 page 387, and that George W. Cummings and G.W. Cummings grantor in a warranty Deed dated August 13, 1875 recorded in Madison County Iowa records, Deed record 11 page 412, is one and the same identical person. I further state that I was well and personally acquainted with J.D. Whitenack grantee in a warranty deed dated August 3, 1881, recorded in Madison County Iowa records, deed record 19 page 262, and that J.D. Whitenack and J.D. Whitenack Jr. grantor in a warranty deed dated July 28, 1881, recorded in Madison County Iowa records, deed record 19, page 361 is one and the same identical person. I further state that I was well and personally acquainted with D.C. McCallon grantee in a warranty deed dated July 28, 1881, recorded in Madison County, Iowa records, deed record 19 page 361 and that David C. McCallon grantor in a warranty deed dated November 26, 1884 and recorded in Madison County Iowa records, Deed Record 24, page 53, is one and the same identical person. I further state that I am well and personally acquainted with my brother Mark L. Thomson grantee in a warranty deed dated November 26, 1884, recorded in Madison County Iowa Records, deed Record 24 page 53 and that M.L. Thomson grantor in a warranty deed dated February 2, 1892 recorded in Madison County Iowa records, deed record 32, page 276 is one and the same person; and that wherever the name of David L. Beezley and David Beezley is mentioned in the title to the North Half (N $\frac{1}{2}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 29, Township 77 North, Range 28 West of the 5th P.M. Iowa, that it refers to one and the same person, and that wherever the name Davis Rankin and David Rankin is mentioned it refers to one and the same person, and wherever the name G.W. Cummings and George W. Cummings is mentioned it refers to one and the same person, and wherever the name of J.D. Whitenack and J.D. Whitenack Jr. is mentioned it refers to one and the same person, and wherever the name of D.C. McCallon and David C. McCallon is mentioned it refers to one and the same person, and wherever the name of Mark L. Thomson and M.L. Thomson is mentioned it refers to one and the same person.
