That Lemon Collins, Anderson Collins and Martin Collins named in the registry of heirs of said Barnabas Ray; are the same and identical persons as Lemon A. Collins, Anderson E. Collins, and Martin A. Allcock, Simon M. Allcock, and Marion R. Allcock, who were defendants in a partition suit brought by Ann R. Odell at No. 3362 in the Circuit Court of Madison County, Iowa.

That Ann R. Allcock was the wife of said L.W. Allcock, or Lorenzo W. Allcock, and that after his deeth, she married Solomon Odell, and that Ann R. Allcock, Ann R. Odell and A.B. Odell, as the names appear in the chain of title to the real estate before described is one and the same person. That said Solomon Odell was commonly known as Sol Odell, and that Solomon Odell and that Solomon Solomo and that Salomon Odell and Sol Odell as the names appear in the chain of title to said real estate was one and the same person. That I have been personally acquainted with all of the persons named herein and the facts stated above are true as I believe.
