I, R.J. Crawford of said County and State on oath say that
I have been a resident of Madison County, Iowa, since in the year 1852, residing during
said time within three miles of Section Twenty-four (24) in Township Seventy-six (76) said time within three miles of Section Twenty-four (24) in Township Seventy-six (76) North, of Range Twenty-seven (27) West of the 5th P.W. Iowa; that I am a son of Oliver Crawford and Lucinda Crawford who on or about April 8th, 1857, conveyed the South East Quarter (4) of the North East Quarter (4) of said Section, Township, and range, and other land to Thomas W. Folwell, the deed appearing of record in doed record "H" of Madison County, Iowa, at page 94 thereof, and that the Oliver Crawford and J. Wilkin or J.W. Wilkin granters in said deed of conveyance are the same and identical person as the Oliver Crawford and J. Wilkin person as the Oliver Crawford and John W. Wilkin person as an analysis of said land from James Crofford and John W. Wilkin named as grantees in the conveyance of said land from James Crofford and John W. Wilkin named as grantees in the conveyance of said land from James Connel and wife Margaret Connel on or about February 7th, 1855, the deed appearing of record in deed record "A" of said County at page 605 thereof, and that James Connell, as his name appears in some places in said conveyance, was in fact James Connel, to whom James M. Wilkin and Oliver Crawford, who on or about August 19th, 1859, conveyed a part of said land to and Olivor Crawford, who on or about August 19th, 1859, conveyed a part of said land to Robert Wilkin, the deed of conveyance being recorded in deed record two (2) of said County at page 247 thereof. That I am s nephew of the J.W. Wilkin or John W. Wilkin, and a grandson of said Robert Wilkin, being a son of his daughter Lucinda Crawford. That I was personally acquainted with J.M. Carson, the grantee in a convoyance dated January 6th, 1882, from Thomas W. Folwell and wife, of the West Half $(\frac{1}{2})$ of the South East Quarter $(\frac{1}{4})$ of the North East Quarter (4) of the Section, township, and range referred to, the conveyance appearing of record in deed record Twenty (20) at page 230 thereof, and that he was the same and identical man as Jas. M. Carson, who with his wife Jane Carson, on or about Hovember 29th, 1884, conveyed said premises and other land to Joseph H. Hadden and Mary E. Hadden, the conveyance appearing of record in deed record Twenty-one (21) of Madison County, Iowa, at page 357 thereof; and that the said Joseph H. Hadden and Mary E. Hadden were the same and identical persons as the Joseph Harvey Hadden and Mary E. Hadden who on or about December 15, 1892, conveyed said real estate to Levi B. Phillips, the conveyance appearing of record in deed record thirty three (33) of said County, at page twelve (12) thereof. That L.B. Phillips who was grantee in a conveyance from C. Danforth of the one third (1/3) of the east three eights (3/8) of the South west quarter (4) of the north east quarter (4) of said section, township, and range, which conveyance appears of record in deed record thirty-nine (39) of said County and State, at page 73 thereof, was the same and identical person as Levi B. Phillips who with his wife Jennie Phillips on or about March 15, 1901, convoyed the said real estate and other land to I.M. McKinney, the deed appearing of record in deed record forty two (42) of said County and State, at page 273 thereof. That I was acquainted with the family of Samuel Dorrance who died intestate in Madison County, Iowa, leaving surviving him his widow Mary Dorrance, and as his only heirs at law James H. Dorrance, Martha J. White, and William S. Dorrance; and that said James H. Dorrance and Martha J. White were the same persons who with L. Dorrance or Louisana Dorrance the wife of James H. Dorrance, and Sam'l M. White, the husband of Martha J. White on or about February 3rd, 1868, executed a conveyance of their interest in the north east quarter (1) of the south east quarter (2) of said Section, township, and range the conveyance appearing of record in deed record "U" of said County and State at page 422 thereof, to said William S. Dorrance, and that he was the same person as the W.S. Dorrance, who on or about September 3, 1870, conveyed said land to Joseph Atchison, the conveyance appearing in deed record four (4) of said County, at page 53 thereof. That said Joseph Atchison was the same and identical person as Joseph A. Atcherson (as his name appears) who on or about October 17, 1871, conveyed the north half of said forty acros to Eliza Jane Cracroft, the deed appearing of record in deed record six (6) of said County, at page 147 thereof; and was also the same person as the Joseph A. Atcherson or Acherson (as his name appears) who on the date last mentioned conveyed the south half of said Forty acre tract to N.F. Loomis, the deed appearing of record in deed record six (6) of said County, at page 299 thereof. That Alexander Patterson to whom J.3. Tullis, Sheriff, on or about July 27, 1872, convoyed the twenty acre tract last above referred to, the conveyance appearing of record in deed record five (5) of said County, at page 547 thereof, was the same and identical man as the Alex Pattison or Alexander Pattison who on or about October 1st, 1872, conveyed the same real estate to Jas. M. Carson, the convoyance appearing of record in doed record seven (7) of said County, at page 49 thereof. That R.B. Coe never had possession of any of the real estate herein described, especially of any part of the south west querter $(\frac{1}{4})$ of the north east quarter $(\frac{1}{4})$ of said section, or any part of the south west quarter $(\frac{1}{4})$ of the north east quarter $(\frac{1}{4})$ of said section, but did in fact about thirty years also buy from Thomas W. Wilkin, the convoyance appearing of record in deed record Seventeen (17) of said County, at page 116 thereof. That J.W. Wilkin grantee in said deed was the same of said County, at page 116 thereof. Wilkin grantee in the said deed from Temperance Tripp was the same and identical person as Jane Wilkin named in the registry of heirs of said Robert Wilkin, as the widow of his deceased son Matthew and as the Mary J. Wilkin grantor in the conveyance to John McClain aforesaid; that J.P. Wilkin named as grantees and identical person and identical person. ntee in the aforesaid conveyance from Temperance Tripp was the same and identical person as Juan Pornedez Wilkin named in the registry of heirs of said Robert Wilkin, deceased, and as the J.T. Wilkin a grantor in the conveyance to John McClain aforesaid; that 8. Wilkin grantoe in the conveyance from Temperance Tripp aforesaid was the same and iden-
