I, S.E.Bonham, being first duly sworn, on my oath depose

and say that the R.E.Bonham named as grantee in a deed from Cena C.Hasty and husband, recorded

ed in Town Lot Deed Record 6, page 265, conveying Lots 64 and 65 in the Town of Macksburg, Iowa, was the same and identical person as the Rosa E.Bonham, who, together with her husband Benjamin S.Bonham, conveyed said Lots 64 and 65 to Alexander Bonham Sr. by deed dated April 1st, 1889 and recorded in Town Lot Deed Record 4, page 286. That the above named Alexander Bonham Sr. was the same and identical person as the Alexander Bonham, the settlement of whose estate is shown in Probate Index "D", page 369. That the Benjamin S.Bonham, named in the registry of heirs filed in the settlement of said estate was the same and identical person as the B.S.Bonham named as one of the grantors in a deed conveying said lots to Delia E. Pearson, dated December 22nd, 1900, and recorded in Town Lot Deed Record 11, page 236.

That the Delia E.Pearson, named as grantee in said last mentioned deed, was the same and identical person as the Della E.Pearson named in said registry of heirs, and as the Delia E.Pearson, named as grantee in deed dated May 9th 1910 and recorded in Town Lot Deed Record 11, page 395, also named as grantee in deed dated February 15th, 1913 and recorded in Town Lot Deed Record 13, page 110, and also named as grantor in deed dated January 7th, 1913 and recorded in Town Lot Deed Record 19---, page 28---. That the Jennie L.Sprague, named as one of the grantors in deed dated May 9th, 1910, and recorded in Town Lot Deed Record 11, page 395, was the same and identical person as the Jennie Sprague named in said registry of heirs.

That the said Delia E.Pearson was the only child and heir at law of Phebe Pearson, a deceased daughter of said Alexander Bonham and the said Dora Hayden and Jennie Sprague named in said registry of heirs were the only children and heirs at law of Tacy Pearson, another deceased daughter of said Alexander Bonham and that said Phebe Pearson and said Tacy Pearson each died prior to the death of their father, the said Alexander Bonham.

All of the above records being of Madison County, Iowa.
