Iowa, being duly eworn, depose and on oath say, that I am a son of George W. Miller, SR.,

and Elizabeth Miller, both deceased, that the soid George W. Miller, Sr., at the time of his death was the owner of the North East Quarter (Fractional) (4) of Section Two (2) in Township Seventy-six (76) North, of Range Twenty-eight (28) West of 5th P.M., Madison County, Iowa, and the said George W. Miller, Sr., left surviving him William K. Miller, John B. Miller, McK Miller, this affiant, George W. Miller, Jr., James E. Miller, sons, and Jennie B Boorbower a daughter, as his only heirs at law, and Elizabeth Miller as his surviving spouse That the said George W. Miller, Sr., died testate, devising to the said surviving spouse a life estate in the above described real estate, and the record does not show that the said widow over accepted the terms of said will, and this affiant states that he was the agent of the said Elizabeth Miller from the time of the death of her said husband to the time of her death which occured September, 14th, 1912, and I know that the said Elizabeth Miller did in fact accept the provisions of said will, and did accept the rents and profits of said real estate from the time of the death of her said husband up to the time of her death, for I collected said rents and profits for her and paid them to her and for her, and I know that she never had any intention of claiming or accepting any dower or distributive share i said real estate.

That I have examined the abstract to the above real estate prepared by 0. E. Beach, wherein is shown taxes assessed against William Killer in Lee Township for the years 1891 and 1892, and in Douglas Ecomethip for 1903, and Crawford Township for 1903 and in Walmut Twonship for 1909, and against Goo. Hiller for 1895 in Grand River Township, and I know the the perties against whom said taxes are assessed are not either of the heirs at law named herein, that the said William Miller never lived in either of the Townships named and Georg-W.
