I was also acquainted with A.McHarper to whom Henry Cox conveyed above described lotsby deed dated October 9" 1856, and recorded in Record "E", page 215, and know that he was the same and identical person as the A.M.Harper who, together with his wife, Mary E.Harper, subsequently conveyed said lots to Samuel W.Marn by deed dated April 13" 1857 and recorded in Record "E" page 345.
