I,John L.Gamble, of said County and State, being first duly sworn, do, upon my cath, depose and say:— That I am the same identical person as the J.L.Gamble who executed a mortgage on the Si Si NE 18-75-29 to Tidrick Terrill Co., dated January 1st, 1910 and recorded in Mortgage Record 36 at Page 478 of the records of said County, and who executed a mortgage on same premises to Samuel H.Joeckel, dated June 5th, 1910 and recorded in Mertgage Record 44 at Page 307 of said records. That it was the intention in the first mortgage to make the same subject to the mortgage to W.L.Smalley for £1300.00 dated May 2nd, 1905 and recorded in Mortgage Record 46 at Page 259 of said records and the interest thereon to the date of said mortgage to Tidrick Terrill Co. That it was the intention in giving the mortgage to Samuel H.Joeckel to make the same subject to both the said mortgage to W.L.Smalley and the one to Tidrick Terril Co., they being the only mortgages on said land at the time of the execution of said mortgage to said Joeckel.

That at the time of making the mortgage to Tidrick-Terrill Co.and the one to said Samuel H.Joeckel I thought the mortgage to W.L.Smalley was for only \$1200.00 and told the scrivener who drew the mortgage to Tidrick Terrill Co.there was about \$1250.00 against the place and told the scrivener who drew the Samuel H.Joeckel mortgage there was about \$1500.00 against the place and as we did not have the mortgages or the record to refer to at the time of drawing the said mortgages we just put the Tidrick Terrill Co.mortgage "Subject to encumbrance of Twelve Hundred and Fifty Dollars" and the Samuel H.Joeckel mortgage "Except mortgage of \$1500.00".
