I, Joshua Bennett, of said State and County, being first duly sworn, on my oath depose and say that I was well and personally acquainted with Jacob Bennett, dec'd, who died testate on or about February 1st, 1882, leaving as his heirs at law Hannah Fee, Sarrah Bennett, Dereck Bennett, Joshua Bennett, Edward Bennett, Andrew Bennett, Miriah Strakengeess, Francis Bennett, Elisabeth Letta, Etna Taylor and Samantha Hornbeck and I well and personally know that the above named heirs were the only living heirs at law of the said Jacob Bennett at the time of his death, that he left no widow and that his son, David Bennett, died intestate and without issue, on or about February 6th, 1854. And I further depose and say that I was well and personally acquainted with Sarah Bennett, one of the heirs at law of the said Jacob Bennett, dec'd, and I well and personally know that Sally or Sallie Bennett, one of the devisees in the will of the said Jacob Bennett, dec'd, Sarah Bennett, one of the grantees in a Warranty Deed, dated December 20th, 1882, executed by Etna Taylor and husband John S. Taylor and conveying the undivided  $\frac{2}{11}$  of the  $\frac{1}{2}$  NW $\frac{1}{4}$  26-77-28 and other lands, Sarah Bennett, one of the grantees in a Warranty Deed, of date December 20th, 1882, executed by Derrick Bennett and wife Nancy J. Bennett and conveying the undivided  $\frac{1}{11}$  of the  $\frac{1}{2}$  NW $\frac{1}{4}$  26-77-28 and other lands, and Sally Bennett, one of the grantors in a Warranty Deed, dated December 4th, 1883, conveying the undivided  $\frac{6}{8}$  of the  $\frac{1}{2}$  NW $\frac{1}{4}$  26-77-28 and other lands, are one and the same identical persons, and the same and identical person as Sarrah Bennett, one of the heirs named in the Registry of heirs filed in the estate of the said Jacob Bennett, dec'd. And I well and personally know that Derrick Bennett, who together with his wife Nancy J. Bennett, executed a Warranty Deed of date December 20th, 1882, conveying the undivided  $\frac{1}{11}$  of the  $\frac{1}{2}$  NW $\frac{1}{4}$  26-77-28 and other lands to Joshua Bennett et al., was one and the same identical person as Dereck Bennett, one of the heirs named in the Registry of heirs filed in the estate of Jacob Bennett, dec'd.

Hornback executed a Warranty Deed of date October 31st, 1882, conveying the undivided  $\frac{1}{11}$  of the SW $\frac{1}{4}$  & W $\frac{1}{2}$  & SW $\frac{1}{4}$  NE $\frac{1}{4}$  & SE $\frac{1}{4}$  SE $\frac{1}{4}$  26-77-28, and other lands to Etna Taylor, was one and the same identical person as Samantha Hornbeck, one of the heirs named in the Registry of heirs filed in the estate of Jacob Bennett, Dec'd, and that Maria Strackingast, one of the grantors in a Warranty Deed of date December 4th, 1883, conveying to Andrew Bennett et al the undivided  $\frac{6}{8}$  of the  $\frac{1}{2}$  NW $\frac{1}{4}$  26-77-28 and other lands, was one and the same identical person as Miriah Strackengess, one of the heirs named in the Registry of heirs filed in the estate of Jacob Bennett, dec'd, and the same ~~same~~ and identical person as Maria Strackingast, whose name appears in the granting clause of said last above described Warranty Deed.

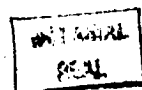
