I,J.P.Breeding of said County and State being sworn depose and say that I am a nephew of Sally Turk who is named as grantee in a deed recorded in Book 20 at page 30 of the Records of Madison County, Iowa, by which deed

the Sally Turk acquired title to Lots Three and Pour in Block Eighteen and all of Block Nineteen in the Town of Bevington, Madison County, Iowa; And the land on the North side of Middle River lying South of the above named Block and Lots.

That I was well and intimately acquainted with the said Sally Turk and her husband and family. Thatthe W.M.Turk who is named as the testator in the last will and testament in case No.1319 Probate in the District Court of Madison County, Iowa, which will was filed November 5th A.D.1897 was the surviving husband of said Sally Turk.
