BEAR CREEK QUARTERLY MEETING OF FRIENDS, HELD AT EARLHAM, IOWA, 9th Mo. 6th 1913.

MEETING OPENED IN JOINT SESSION.

The matter of procuring a release of mortgage held by this meeting on lots in Earlham, Iowa, which was left for further consideration by our last meeting has been before us and we are united in adopting the following minute which the clerks are directed to properly sign on behalf of the meeting:

WHEREAS North Branch Monthly Meeting of Friends situated in Madison County, Iowa, being duly incorporated, obtained good title to and later did sell to Wm. A. Hunter Lots No. 9 and 10, Block No. 16, in the Original Town of Earlham, Madison County, Iowa, and said Wm. A. Hunter did give said Monthly Meeting's Trustees, viz; David Mills, Christopher Wilson, et al, a mortgage on said lots for security for notes given in lieu of cash payment for same. And whereas said Monthly Meeting being a co-ordinate and sub-ordinate branch of this meeting and reporting regularly unto this meeting, and whereas according to the long established and acknowledged rules of the Religious Society of Friends the Quarterly Meetings are superior to and dictatory to the establishing and laying down of the Monthly Meetings constituting and reporting to them, and whereas North Branch Monthly Meeting being few in membership was duly laid down by action of this meeting and now the Quarterly Meeting being the legal successor of said North Branch Monthly Meeting does authorize its Trustees, Abner L. Nowlin, Archibald Henderson, Henry Standing, Alfred Standing and Wm. Clarkson Moffitt to procure and sign a legal instrument of release to the said mortgage given by Wm. A. Hunter on Lots Nine (9) and Ten (10) Block Sixteen (16) in the Original Town of Earlham, Madison County, Iowa, when such mortgage claim shall have been fully paid and satisfaction made for same.
