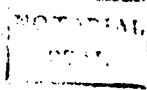

Allecock named as Grantor in the deed to Hiram Hurst conveying the SE $\frac{1}{4}$ of said real estate, dated December 30th, 1851 and recorded in Deed Record A, at Page 110, of the Deed Records of Madison County, Iowa, and was the same identical person as the N.S. Allecock named as Grantor in the deed dated August 7th, 1867, conveying the S $\frac{1}{2}$ NW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 20-75-26 to William H. McClelland and John L. McClelland and which is recorded in Deed Record T, at Page 520 of the Deed Records of Madison County, Iowa. That I was well and personally acquainted with the William H. McClelland named as one of the Grantees in the deed last above described and know that he was the same identical person as the Wm.H. McClelland named as Grantor in the deed dated May 15th, 1872, conveying the undivided one-half ($\frac{1}{2}$) of the S $\frac{1}{2}$ NW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec 20-75-26 to John L. McClelland, which deed is recorded in Deed Record 10, at Page 475 of the Deed Records of Madison County, Iowa. That I was well and personally acquainted with the John L. McClelland named as Grantor in the two last above described deeds and know that he was the same identical person
