State of Iowa Madison County, ss. I, J.W.Eldridge, of said County and State, being first duly sworn, do, upon my oath, depose and say:- That I am the same identical person as the J.W.Eldridge named as one of the grantors in a deed conveying the SE $\frac{1}{4}$ NE $\frac{1}{4}$ SE $\frac{1}{4}$ Sec 19, 75-26 to A. Tusha, dated October 27th, 1898 and recorded in Deed Record No 29 at Page 605 of the Deed Records of Madison County, Iowa and that I am the same identical person as the J.W. Eldredge named in the registry of heirs filed in the office of the Clerk of the District Court of Madison County, Iowa in the matter of the estate of William Eldridge by C.A.Eldridge, Administrator on the 12th day of July, A.D. 1892; that I know of my own personal knowledge that the Rebecca Eldridge named as grantor in said deed was the same and identical person as the Rebecca Eldredge named in said registry of heirs; that the Eliza Quinn who signed said deed was the same identical person as the Louise Quinn named in said registry of heirs and in the granting clause of said deed; that the Frances Eldridge who signed said deed was the same identical person as the Francis Eldridge named in the granting clause thereof and as the Francis Eldredge named in the registry of heirs; that the Ellen Ogburn who signed said deed and is named in the granting clause thereof was the same identical person as the Nancy Ellen Ogburn named in said registry of heirs; that the L.A. Eldridge who signed said deed was the same identical person as the L.A.Eldredge named in said registry of heirs; that the C.A.Eldridge who signed said deed was the same identical person as the C.A.Eldredge named in said registry of heirs, and that the D.M.Eldridge who signed said deed was the same identical person as the D.M.Eldredge named in said registry of heirs. That the said Rebecca Eldridge was my mother and that the other persons named herein were and are my brothers and sisters and that they were the widow and sole ^{and only} heirs ^{in whole} at law of William Eldridge, Deceased, who was my father and who died in Madison County, Iowa on or about the 19th day of May, A.D. 1892. That the spelling of the name Eldredge in said registry of heirs was a mistake or error on the part of the attorney or person who drew such registry of heirs as was also the spelling of my sister's name "Francis" and also writing my sister Eliza Quinn's name as "Louise Quinn". All of the above matters being known to me of my own personal knowledge and I have no interest in making this affidavit except to establish the facts herein set forth. Further deponent sayeth not.
