State of Iowa, Madison County. ss. I, S.M. Compton, of Earlham, Madison County, Iowa, being first duly sworn, depose and say that I was personally acquainted with Josiah W. Burnett, who entered the North Half ($\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Nine (9) Township Seventy-seven (77) North, Range Twenty-eight (28) under certificate #3675 patented to him on May 1, 1855, under U.S. Record Volume 7, page, 258, and that the said Josiah W. Burnett is one and the same party as J.W. Burnett Grantor in a certain Warranty Deed dated April 4, 1861, recorded in Madison County record book "M" page 287. I further state Wm.L. Compton Grantee in a certain Warranty Deed dated October 19, 1887, recorded in Madison County Deed record book 27, page 116, is one and the same person as W.L. Compton Grantor in a certain Warranty Deed dated December 19, 1888, recorded in Madison County Deed record book 27, page 532, and that wherever in the chain of title to the Southwest Quarter (SW $\frac{1}{4}$) of Section Nine (9) and the South Half ($\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Twenty-one (21) all in Township Seventy-seven (77) North, Range Twenty-eight (28) and Lots 3, 4, 5, Block One (1) Allen's Addition to the Original Town of Earlham, Iowa, the name of Wm.L. Compton, W.L. Compton, William Leonard Compton, or William Lenard Compton appears, it refers to one and the same party. I further state that my Mother, Ann Elizabeth Compton Grantee in a certain Warranty Deed dated May 3, 1860, recorded in Madison County Deed record book "L" page 325, is one and the same party as Anna E. Compton Grantor in a certain Warranty Deed dated June 21, 1907, recorded in Madison County Deed record book 46, page 273, and that wherever in the chain of title to the last above described real estate the name of Ann Elizabeth Compton, Anna E. Compton or Ann E. Compton is mentioned it refers to one and the same person.

I further state that Milton Wilson Compton registered as one of the heirs of Martin Compton is one and the same person as Milton W. Compton Plaintiff in a certain petition for divorce as appears in Madison County under Equity case #10858 under Appearance Docket "W" page 83, and wherever in the chain of title to the last above described real estate in this affidavit the name of Milton Wilson Compton, Milton W. Compton, or M.W. Compton appears it refers to one and the same person.

I further state I am personally and well acquainted with my brother Henry Everett Compton listed as one of the heirs of my Mother Ann E. Compton, and he is one and the same person as Henry E. Compton Defendant in a certain divorce suit as appears in Madison County under Equity case #10560 under Judgment Docket "V" page 210; and that wherever in the chain of title to the last above described real estate in this affidavit the name Henry Everett Compton, Henry E. Compton or H.E. Compton appears it refers to one and the same identical person.

I further state in the registry of heirs in my Father, Martin Compton's estate, my name is registered as Sylvanus M. Compton and in the registry of heirs in my Mother, Ann E. Compton's estate my name is registered as Sylvanus Marion Compton. Both registrations Sylvanus M. Compton and Sylvanus Marion Compton refer to myself. I further state my name appears as S.M. Compton in the chain of title to the last above described real estate in this affidavit and this refers to one and the same person as Sylvanus M. Compton, or Sylvanus
