On Ordinance repealing erdinance Ne 87 of the City of Winterset, Iewa, and enacting an ordinance in lieu thereof abolinging the names of certain streets in the City of Winterset, Iewa, and substituting other names thereor.

Be It Ordained by the City Council of Winterset, Icwa:

Sec 1. That erdinance, No 87 of the City of Winterset, Iowa, being an ordinance abeliaking the names of certain streets in the City of Winterset, Iowa, and substituting other names therefor, be and the same is hereby repealed and annuled, and the following enacted in lieu thesef.

Sec. 2. That the names of all the streets or part of streets in the City of Winterset, Iowa, ru ning in north and south direction be, and the same are hereby abelished, and names substituted therefor as follows, to-wit:

The stmeet known as Pelk street is hereby named and shall he known as First Avenue.

The street known as Taylor street is hereby named and shall he known as Second Avenue.

The street known as Locust street is hereby named and shall be known as Third Avenue.

The street knewn as West street, including that part on the south knewn as Elm street, is hereby named and shall be known as Fourth Avenue.

The street known as Webster Street, including that part on the south known as Oak street, is hereby named and shall be known as Pifth Avenue.

The street known as Chase street, including that part on the south known as as Short street, is receby named and shall be known as Sixth Avenue.

The street knewn as Seward street, including that part on the south knewn as Broadway.

18 hereby named and shall be knewn as Seventh Avenue.

The street knewn as Brewn street, including that that part on the south knewn as Lane street, is hereby named and shall be knewn as Eighthiavenue.

The street known as Grant street, through the center of Adkinson's Addition to Winter set, Iowa, is hereby named and shall be known as Nineth Avenue.

The street known as Williams street on the west of Adkinson's Addition to Winterset,

Iowa, is hereby named and shall be known as Teach Avenue.

The street known as Front street is hereby named and shall be known as First street.

The street known as Madison street, including the continuation thereof on the south known as Buffale street, is hereby named and shall be known as Second Street.

The street known as Jackson street is hereby named and shall be known as Third street.

The street known as East Street is hereby named and shall be known as Fourth Street.

The street knewn in its different parts as Gee street, Owen street and Franklin street, is hereby named and shall be knewn as Fifth Street.

The street known as Iewa street is hereby named and shall be known as Sixth Street.

The street known as Walnut street is hereby named and shall be known as Seventh Street.

The street known as Chestnut street is hereby mamed and shall be known as Eighth Street.

The sheet knewn as East Freement street is hereby named and shall be knewn as Wineth

The street or lane running north and south on the east line of the corporation, is hereby named and shall be known as Tenth Street.

Sec 3. That the street known as Burr street, ruming east and west through Jenkin's Addition

to Winterset, Iewa, is hereby abolished as to name, and the same shall be taken as a continuation of Hutching's street and said street shall be known as Hutchings Street.

See, 4. That the street known as Lane street in the south part of Hutching's Addition to Winterset, Iewa, is hereby abolished as to name, and said street taken as a continuation of Short street, and the same shall be known as Short street.

Sec. 5. That all streets and avenues in Winterset, Iewa, running north and south through Winterset, Iewa, a part of which street er avenue is south of Court Avenue, and apart of said street or avenue, is north of Court Avenue, that part lying south of Court Avenue shall be knewn and designated by prefixing the word "South" to the name of the street or avenue, and that part of said street or avenue lying north of Court Avenue, shall be knewn and designated by prefixing the word "North" to the name of said street or avenue, Sec. 6. That all streets and avenues in Winterset, Iewa, running east and west through said city of Winterset, Iewa, apart of which street or avenue is east of the of the:

avenue herein designated as First Avenue, and apart of which street or avenue is west of the avenue, herein designated as First Avenue, and apart of which street or avenue is west of the avenue, herein designated as First Avenue, and apart of which street or avenue is west of the avenue, herein designated as First Avenue, and apart of which street or avenue, that part of said street or avenue, lying east of said First Avenue, shall be known and designated by prefixing the word "East" to the name of the street or avenue, and that part lying west of said First Avenue, shall be known and designated by prefixing the word "West" to the name of the street or avenue.
