State of Iowa, Madison County, as I, Francis Bennett of said state and county, being first duly sworm, upon my oath depose and say, that I am a son of Jacob Bennett, who died in Madison County, Iowa, in the year 1832, and that Susan Bennett, my mother, died prior to the death of the said Jacob Bennett. And this affiant well and personally knows that the Sarrah Bennett who is mentioned in the registry of heirs of the said Jacob Bennett is one and the same identical person as Salley Bennett who was one of the grantors in a deed conveying her interest as such heir to B.N. Clark, H.M. Clark and J.D. Clark, bearing date of Feb'y 12th 1833; also that the Elizabeth Letta mentioned in said régistry of heirs, is the same and identical person as Elizabeth Leddy, who with her husband, joins in the execution of the said above mentioned deed, her true and proper have being Leddy. Also that the Miriah Strackengess, who is mentioned as an heir of said decedent in said registry is one and the same identical person as Maria Strackingast, who, with her husband, joined in the execution of the above mentioned deed as an heir of Jacob Bennett and Susan Bennett, both deceased.

Also that the Samatha Hornbeck who is mentioned at one of said heirs in said registry is the same and identical person as Samantha Hornback, who with her husband, conveyed her interest in certain lambs belonging to said estate to Etha Taylor, another of said heirs, by deed dated October 31st 1832, and also that the Dereck Bennett who is mentioned in said registry as one of said heirs is one and the same identical person as Derrick Bennett, who with his wife, conveyed his interest in the lands of said estate to other heirs of said estate by deed dated December 20th 1832, as shown by the records of Madison County, Iowa, And further that I was well and personally acquainted with the said grantees J.D. Clark, B.N. Clark and H.W. Clark, and well and personally know, that Hugh M. Clark, who with his wife executed a conveyance to James D. Clark of date Peb'y 13th, 1888 is the rame and identical person as the H.M. Clark the grantee of deed of said land, and that James D. Clark, his grantee in the deed last described and J.D. Clark, the grantee in the conveyance thereof before herein mentioned, are one and the Same identical person, and identical with that J.D. Clark who conveyed the land so acquired by deed dated October 18th, 1888 to Hariett Clark.

I have made the foregoing statements from my personal knowledge of the maters set out, and am in no way interested in the subject matter, and further deposit saith not.
