Dist I was well and personally acquainted with one Alvah Buckingham who, on Sentember 1st 1851 entered from the U.S. Government the NE SE Sec. 21.75-27 and who on the 23rd day of September 1851, together with his wife, joined in the execution of a deed of conveyance to above described land to David Bishop, in the name of A.Buckingham, which deed is recorded in deed record "A" page 224, and shown at No.2 of abstract No.7879 to which this affidavit is attached and made a part, and know that Alvah Buckingham and A.Buckingham were one and the same identical person.

That said deed shown at No.2 of said shatract, as appears of record, fails to show the name of grantee therein, but of my own personal knowledge, the said David Bishop was the grantee therein, and that he entered upon said premises after purchasing the same and remained thereon and hald same by peaceable and uninterrupted possession until he sold and conveyed the same to Isaac Debusk on the 5th. day of September 1854.
