Bengé, being duly sworn depose and say as follows: That I have been a resident of Madison County, Iowa, for more than fifty years, that the matters stated herein are of my own knowledge and that I have no interest in making this affidavit except to establish a record of the facts stated herein at the request of Warren P. Bengé.

That the M.A. La Rue named as grantee in a certain deed dated March 8th, 1900, recorded in Deed Record 41 page 436 and conveying the North 60 $\frac{1}{2}$ acres of the South West Fractional Quarter of Section Nineteen in Township Seventy-five North, of Range Twenty-eight West of the 5th P.M. is the same person as the Maude A. La Rue who is named as grantor in a certain warranty deed dated December 31st, 1903, recorded in Deed Record 45 page 504 and conveying the land above described to Roscoe La Rue.

That the A.M. Bengé named as grantee in a certain quit claim deed executed by John G. Huglin and wife, dated January 23^d, 1908, recorded in Deed Record 40 page 405 and conveying the North West Fractional Quarter and the and the North 60 $\frac{1}{2}$ acres of the South West Fractional Quarter of Section Nineteen in Township Seventy-five North, of Range Twenty-eight West of the 5th P.M., is the same person as the Anderson M. Bengé who, together with his wife Eudora P. Bengé, conveyed the West Fractional Half of the North West Quarter of said section to W.P. Bengé on April 1st, 1908, as is shown by Deed Record 48 page 569 and who also, with his wife joining conveyed the North 60 $\frac{1}{2}$ acres of the South West Fractional Quarter of said section to Warren P. Bengé on May 3^d, 1911, as is shown by Deed Record 53 page 220, and I am that person.

That the said W.P. Bengé who is named as grantee in the said deed above described and recorded in Deed Record 48 page 569, the Warren P. Bengé who is named as grantee in the patent from the United States dated March 3^d, 1910, recorded in Deed Record 51 page 624 and conveying the East Half ($\frac{1}{2}$) of the North West Quarter ($\frac{1}{4}$) of Section Nineteen (19) in Township Seventy-five (75) North, of Range Twenty-eight (28) West of the 5th P.M. and the Warren P. Bengé who with his wife executed to the Iowa Loan & Trust Company a certain mortgage of date March 17th, 1916 conveying the North West Fractional Quarter and the North 60 $\frac{1}{2}$ acres of the South West Fractional Quarter of Section Nineteen in Township Seventy-five North, of Range Twenty-eight West of the 5th P.M., which mortgage is recorded in Mortgage Record 61 page 620, is one and the same person his full name being Warren P. Bengé.

That the W.N. Elsbury named as grantee in a certain warranty deed executed by W.B. Beebe and wife, dated January 12th 1882, and recorded in Deed Record 17 page 309 which deed describes

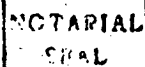
