State of Iowa, Madison County. ss. I, W.G.Dorrell, of said County and State, on oath say that I have been a resident of Madison County, Iowa, continuously for more than sixty years last past, and for many years lived in Walnut township in said County, being township seventy-four (74) north, of range twenty-seven (27) west of the fifth P.M.Iowa, and was acquainted with the early settlers of said township; that Robert Eyre, grantee in a conveyance of the north west quarter ($\frac{1}{4}$) of the north east quarter ($\frac{1}{4}$) of section thirty-three (33), in said township and range herein before referred to, from Rhoda Bryan, guardian, as grantor, dated, December 24, 1869, was the same and identical person as Robert Eyer, grantee in a conveyance of the remaining interest in the same tract of real estate from Paul Macy and wife, Doshia, Rhoda Bryan and her husband, Thomas P. Bryan, John T. Painter, Helena Painter, Quimby Pierce and his wife, Virginia Pierce, dated, November 15, 1869; and that the Rhoda Bryan, Doshia Macy, and Virginia Pierce are the same and identical persons as Rhoda Painter, Doshia Painter and Virginia Painter, respectively, who were children and heirs at law of Jesse Painter and Susannah Painter; and that the said John T. Painter and Helena Painter, two of said grantors, were unmarried at the time of the execution of said deed, as I remember and believe; that in the chain of title to said real estate Robert Eyer and Robert Eyre are one and the same person, and Daniel Eyer and Daniel Eyre are one and the same person; that Helena Painter, one of the mortgagees, in a mortgage of said real estate given by Robert Eyre and wife, dated December 4, 1869, was the same and identical person as Helen Pierce who on or about December 20, 1879 joined in a release of said mortgage; that George M. Stalloop, as his name appears, who entered the south west quarter ($\frac{1}{4}$) of the south east quarter ($\frac{1}{4}$) of section twenty-eight (28) in said township and range, was the same and identical person as the George W. Stalloop who entered the north east quarter ($\frac{1}{4}$) of the north east quarter ($\frac{1}{4}$) of section thirty-three (33) of said township and range, and as the G. W. Stalloop who with his wife, Nancy H. Stalloop, on or about June 15, 1857, conveyed said land to William Fivecoat; that W. P. Shipley and William P. Shipley, the names appearing in connection with the mortgage and its release on the north east quarter ($\frac{1}{4}$) of the north east quarter ($\frac{1}{4}$) of section thirty-three (33) of said township and range, given by William Fivecoat and wife Lucinda, dated June 15, 1857, was one and the same man.


That while I have not at this time a distinct, personal recollection of all of the
