State of Iowa, Madison County, ss. I, Wm McKibben, of Madison County, Iowa, being first duly sworn, depose and say that I was well and personally acquainted with Edna Wilson, a single person, and Grantee in a certain Warranty Deed dated September 18, 1860, filed for record with the recorder of Madison County, Iowa, on the 13th day of February 1863, as shown by Deed Record "M", page 422; conveying the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Five (5) Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M. Iowa. I further say that the said Edna Wilson intermarried on the ----- day of ----- 1863 with one William H. Kramer, and I further say that Edna Kramer, (formerly Edna Wilson) one of the Grantors in a certain Warranty Deed dated July 4, 1866, filed for record with the Recorder of Madison County, Iowa, on July 5, 1866, as shown by Deed Record "Q" page 555, conveying the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Five (5) Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M. Iowa; and Edna Wilson Grantee, is one and the same identical person. I further state that at the time Edna Kramer executed the above mentioned Warranty Deed dated July 4, 1866, she had no children.

I further state I was well and personally acquainted with William H. Kramer, Grantee in a certain Warranty Deed dated July 4, 1866, filed for record July 5, 1866, with the Recorder of Madison County, Iowa, as shown by Deed Record "Q" page 556; conveying the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Five (5) Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M. Iowa. I further state I was well and personally acquainted with W.H. Kramer, one of the Grantors in a certain Warranty Deed dated March 27, 1868, filed for record with the Recorder of Madison County, Iowa, on the 5th day of August, 1868, as shown by Deed Record "V" page 569; conveying the West Half (W $\frac{1}{2}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 5, Twp. 77 North, Range 28, excepting right of way across said land; and I do say that the said William H. Kramer and W.H. Kramer is one and the same identical person.
