In the District Court of the United States for the Southern District of Iowa. Central Division. Central Trust Company of New York, as Trustee, Complainant, Chicago, Rock Island and Pacific Rail Road Company,

This cause came on to be heard at this term and was argued by counsel for the complainant and for the defendant; and thereupon upon consideration thereof, it was Ordered, Adjudged and

Decreed.as follows.vis: l.Walter C.Noyes Esq.of New York City is hereby appointed ancillary receiver of the defendant Chicago, Rock Island and Pacific Railroad Company and of all the property and assets of said defendant with the jurisdiction of this court, with power and authority to take possession of and hold the same; to bring suit for collect, receive and reduce to possession all the property and assets, books, papers, accounts, claims, choses in action, and all other property whatsoever of said defendant situated within the jurisdiction of this court; to institute, prosecute, intervene in or become a party to any and all such actions, suits or proceedings as he may deem necessary or proper for the protection, maintenance, collection or en forcement of any of the property, assets, eredits, accounts, claims or choses in action of sai defendant within the jurisdiction of this court, and to incur such expense as may be necessary or proper in connection with said ancillary receivership.

2. Each and every of the officers, directors, agents and employees of the said defendant and all other persons whomsoeper are hereby required and commanded forthwith upon demand of the said ancillary receiver or of his duly authorised agent to turn over to said ancillary receiver or to his duly authorised agent, any and all books of account, vouchers, papers, moneys or other property in his or in their hands,or under his or their custody or control.

5. The said defendant and its officers, directors, agents and employees, and all other persons claiming to act by, through or under the said defendant, and all other persons whomsoeve; are hereby enjoined and restrained from interfering in any way whatever with the possession or management of any part of the property of the said defendant within the jurisdiction of this court or from interfering in any way to prevent the discharge by the ancillary received of any of his duties, and all creditors and stockholders of the said defendant and all other persons whomsoever are hereby enjoined and restfisined from instituting or prosecuting any suits, actions or proceedings at law or in equity against the said defendant, and from levying any attachment, execution or other process upon or against any of the preperty of said defendant within the jurisdiction of this court or from taking or attempting to take into their possession any of the said property of the said defendant.

4. And it appearing to this court that the said Walter C. Noyes was appointed receiver o the said defendant and of all the property and assets of said defendant of whatever kind and whereacever situated by order of the District Court of the United States for the Southern District of New York, dated January 18th, 1915, and that as provided in said order the said Walter C.Noyes has made and filed his bond in the sum of \$75,000.00 in said District Court of the United States for the Southern District of New York itiis ordered that he give a further bond in the sum of \$10,000.00 to be filed by the said Walter C.Noyes as ancialary receiver herein.
