I, Mrs Julia Miller, being first duly sworn, on my oath depose and say that I am a daughter of Jonathan McKee who died in Madison County, Iowa, about May 12th 1890, seized of the Northwest Quarter ($\frac{1}{4}$) Section Twenty-eight (28) Township Seventy-four (74) North, Range Twenty-nine (29) West of the 5th P.M., and that the said Jonathan McKee was the same and identical person as the Jona McKee who acquired title to the South Half ($\frac{1}{2}$) of the Northwest Quarter ($\frac{1}{4}$) and the Northeast Quarter ($\frac{1}{4}$) of the Northwest Quarter ($\frac{1}{4}$) of said Section Twenty-eight (28), by deed from Harvey Ray and wife dated June 30th 1875 and recorded in Deed Record 12, page 469, and that wherever in the chain of title to said NW $\frac{1}{4}$ of said Sec. 28, the names Jona McKee, Jono McKee, Jonathan McKee and J. McKee occur, they refer to the same and identical person, to-wit:- my father, the said Jonathan McKee.

I further depose and say that Clark McKee and Emma McKee who conveyed the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Sec 28 to the said Jonathan McKee by deed recorded in Deed Record 21, page 86, were husband and wife on the date of said conveyance, the said Clark McKee being the uncle of this affiant.

I further depose and say that the Jonathan McKee who conveyed the W $\frac{1}{2}$ NW $\frac{1}{4}$ of said Sec 28 to Elizabeth McKee on December 6th 1878 by deed recorded in Deed Record 16, page 469 was the husband of said Elizabeth McKee, grantee in said deed, on said date; and that the said Elizabeth McKee subsequently reconveyed said land to the said Jonathan McKee on December 23rd 1882 by deed recorded in Deed Record 20, page 498.

I further depose and say that the Elizabeth P. McKee named in the registry of heirs of the said Jonathan McKee was the same and identical person as Elizabeth P. Jones, and as Lizzie Jones named in the proceedings by administrator for the sale of said real estate; that the Laurence C. McKee named in said registry of heirs was the same and identical person as Lorenzo C. McKee named in said proceedings above referred to; that this affiant is the July A. McKee named in the said registry of heirs and is the same person as the Julia A. McKee named in the proceedings above referred to; and that the Adda M. McKee named in said registry of heirs was the same person as the Addie M. McKee named in said proceedings above referred to. All the above records being in Madison County, Iowa.
