M.L.Silliman a resident of said county and state, being first duly sworn on my oath depose and say that I am well and personally acquainted with J.O.Finley, who is the grantee in a deed from John J.Cameron, as executor of the estate and will of James R.Cameron, deceased, dated February 23rd, 1906, conveying the W $\frac{1}{2}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  & E $\frac{1}{2}$  NW $\frac{1}{4}$  NE $\frac{1}{4}$  Sec 23-76-29, as shown by deed recorded in Deed Record 50, page 1 of the records of Madison County, Iowa, and with the J.O.Finley, grantee in a deed from R.E.Cameron et al, heirs at law of said James R.Cameron, deceased, conveying said real estate, as shown by deed recorded in Deed Record 50, page 1 of the records of said county, and I well and personally know that he is the same and identical person as the James O.Finley named in the granting clause and acknowledgment of a deed conveying the NE $\frac{1}{4}$  NE $\frac{1}{4}$  Sec 23, (except about three-fourths of an acre in the Northeast corner thereof for school house) also the E $\frac{1}{2}$  NW $\frac{1}{4}$  NE $\frac{1}{4}$  Sec 23-76-29, as shown by deed recorded in Deed Record 53, page 310 of the records of said county; that I am also well and personally acquainted with S.G.Hoeness, grantee in a deed from E.L.McCorkle and wife, conveying the NW $\frac{1}{4}$  NW $\frac{1}{4}$  Sec. 24-76-29, and recorded in Deed Record 49, page 75 of the records of said county, and well and personally know that he is the same and identical person as the Samuel G.Hoeness as shown in the agreement with John C.Sawhill, dated April 14th, 1909, and recorded in Miscellaneous Record 17, page 288 of the records of said county, and also the same person as Samuel G. Hoeness, who with his wife Mable, executed a mortgage for \$ 4000.00 to James O.Finley, dated February 16th, 1912, upon the NW $\frac{1}{4}$  NW $\frac{1}{4}$  Sec 24-76-29 and other land, and recorded in Mortgage record 46, page 499 of the records of Madison County, Iowa.
