State of Iowa Madison County SS:- I.W.G.Dorrell of said county and state on oath do depose and say that I have been a resident of said county for more than 72 years last past during which time I have been acquainted with the title to the southwest quarter of section 36 in township 75 north, range 28, Madison County Iowa, and was personally acquainted with Peter Shainholts and wife, Frances I. Shainbolt and worked for Peter Shainholts at digging a well on said premises, and know that Peter Shainholts named as grantee in the deed conveying said premises from John Mackey and wife, dated May 23, 1856, and recorded May 23, 1856, in deed record "D", page 499, and Peter Shainholts as his name appears in the index of said deed, and Peter Shainholts and wife, Frances I. Shainholts, who conveyed the east half of southwest quarter of section 36 in township 75 north, range 28, Madison county Iowa, to Emily Shainholts by warranty deed dated September 22, 1856, and recorder November 3, 1856, in deed record "F", page 146, and Peter Shainholts who with his wife, Frances I. Shainholts, executed a certain warranty deed conveying the west half of southwest quarter of section 36 in township 75 north range 28, Madison County, Iowa, to Susan Shainholts of date September 22, 1856, and recorded

November 3, 1856, in deed record "F" page 144, were one and the same identical person, his true name being Peter Shainholts. That Peter Shainholts's wife's true name was Frances I. Shainholts, and that the spelling of her name as Frances I. Sha~~y~~nholts in the deed last above mentioned as wife of grantee was an error. I was also well and personally acquainted with Susan Shainholts named as grantee in the last above mentioned deed from Peter Shainholts and wife Frances I. Shainholts, and that she was intermarried with James Pierce, and that Susan Shainholts is the same and identical person as Susan Pierce who with James Pierce, executed a warranty deed conveying last above described premises to J. H. Thompson, of date June 18, 1869, and recorded July 12, 1869, in deed record 2 page 57. That the Emily Shainholts named as grantee in the deed above referred to and recorded in deed record "F" page 146, was the same and identical person as the Emily Erman who joined as wife of, with John Erman, in the warranty deed dated June 16th 1869, to J. H. Thompson, which deed was recorded July 12, 1869 in deed record 2, page 58 conveying land described in last above mentioned deed, viz: The east half of the southwest quarter of section 36 in township 75 north, range 28, Madison county Iowa, and in which deed it recites: "John Erman and Emily Erman, his wife, (Formerly Emily Shainholts)" All the records above referred to are of the records of Madison County, Iowa.
