State of Iowa Madison County SS;- I, James Kirby, of said County and State, being first duly sworn, upon my oath depose and say, that I have been a resident of Madison County, Iowa, for fifteen years last past; that I ^{was} well and personally acquainted with Joel D. Gordon, who died testate in Madison County, Iowa, on or about June 6, 1905; and that I was well and personally acquainted with his children and heirs at law; and that I acted as Administrator with will annexed of the Estate of said Joel D. Gordon. That in the proceedings had in his Estate, the name of the decedent is given in various places as J.D. Gordon and J.D. Gordon, but that his correct name was Joel D (or J.D.) Gordon, and that the said Joel D. Gordon, grantee in the deed recorded in Deed Record 13, page 159 of the records of Madison County, Iowa, conveying the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 20-76-26, was the same and identical person as the Joel D. Gordon above named. That the spelling of the names of the children in the Registry of Heirs filed in the Estate of said decedent by this affiant as Administrator of said Estate as Gordon was an error, their correct name being Gordon. That Serena J. Gordon named in the will of said decedent was the same person as Miss S. J. Gordon named in said Registry of Heirs, and that she is also the same and identical person as the Jennie Gordon, one of the grantors in a certain Warranty Deed to J. O. Overton recorded in Deed Record 44, page 381 of said records, and conveying said forty acres; that Mrs. L. E. Patterson named in said Registry of Heirs was the same person as Ella Patterson, who, together with her husband, joined in the execution

of said last mentioned deed; that Miss M.A. Gordon named in said Registry of Heirs was the same and identical person as Maud Fielder, who, together with her husband, joined in the execution of said last mentioned deed; that F.W. I further state that I have no interest in the title to the land above described, but make this affidavit at the request of the present owner of said land for the purpose of making more complete the matters set forth in the affidavit made by this affiant recorded in Miscellaneous Record 16, page 512 of the records of said county.
