State of Iowa Dallas County, SS.I, Rachel Holderbaum, being first duly sworn on oath depose and say, that I was well and personally acquainted with Henry D. Holderbaum, grantee in a certain quit claim deed conveying the North half ($\frac{1}{2}$) of Section Seventeen (17) Township Seventy-seven (77) North, Range Twenty-nine (29) West of the fifth P.M. Iowa and recorded in Deed Record Two (2) on Page One hundred Twenty-seven (127) of the records of Madison County, Iowa, and I do state of my own personal knowledge that the said Henry D. Holderbaum grantee is the same person as H.D. Holderbaum referred to in Sheriff's Deed conveying the above described real estate and recorded in Deed Record A on Page Two Hundred Eighty-six (286) of the records of Madison County, Iowa. And I do state that the said Henry D. Holderbaum grantee is the same person as H.D. Holderbaum, registered as one of the heirs to the Estate of Christina Holderbaum by the Administrator of said estate on April 20th 1889. And I do state of my own personal knowledge that the said Henry D. Holderbaum grantee is the same person as H.D. Holderbaum referred to as defendant in the foreclosure proceedings in the Circuit Court of Iowa, in and for Madison County, April Term A.D. 1880.

That I was also well and personally acquainted with Josiah Hockstetler, referred to as Josiah Hockstetler in Sheriff's Deed recorded in Deed Record A on Page Two Hundred Eighty Six (286) of the records of Madison County, Iowa, and I state of my own personal knowledge that the Josiah Hockstetler named as defendant to a suit brought by Christian Holderbaum in the Circuit Court of Iowa in and for Madison County during the April Term A.D. 1884, is the same person as the said Josiah Hockstetler grantee in said Sheriff's deed, that the spelling of the name Hockstetler was a typographical error, wherein the letter "k" was substituted for the letter "h".

That I am well and personally acquainted with Caroline A. Holderbaum mentioned in the transcript of a decree of the United States Circuit Court, Southern District of Iowa, Central Division, rendered May 18th. 1891, filed in the office of the Clerk of the District Court of Madison County, Iowa, on August 22nd. 1892, and I state of my own personal knowledge that the said Caroline A. Holderbaum is the same person as Amanda Holderbaum, registered as one of

the heirs to the estate of Christina Holderbaum, by the Administrator of said estate on April 20th, 1889, that she has since intermarried with J.C. Thraikill, and that Caroline A. Holderbaum, Amanda Holderbaum, and Carolina Amanda Thraikill are one and the same person.

That I am well and personally acquainted with Jacob Augustus Holderbaum mentioned in the transcript of the decree above mentioned, and I state of my own personal knowledge that the said Jacob Augustus Holderbaum is the same person as J.A. Holderbaum, registered as one of the heirs to the estate of Christina Holderbaum by the Administrator of said estate, on April 20th, 1889.
