State of Iowa, Dallas County, SS, We, Cora Thornton (formerly Cora Holderbaum) and Jacob A. Holderbaum being each first duly sworn, on oath each for herself and himself depose and state as follows:- That the said Cora Thornton (formerly Cora Holderbaum) and Jacob A. Holderbaum were two of the mortgagors in a certain mortgage given to the German Savings Bank of Davenport, Iowa on the 11th day of August A.D. 1899 and recorded in book 40 page 212 of the records of Madison County, Iowa, conveying therein the North half (N $\frac{1}{2}$ ) of Section Seventeen (17) Township Seventy-seven (77) North, Range Twenty-nine (29) west of the fifth P.M.
