State of Iowa Madison County, Iowa. SS: I, Willis Mobley of said County and State being first duly sworn upon oath depose and say that I am now and have been for 60 years last past a resident of Madison County, Iowa, and well and personally acquainted with the persons named, in the last two paragraphs hereof.

(1) That Jehu C. Jones, grantee in the Special Warranty Deed recorded in Deed Record "W", page 266 of the records of Madison County, Iowa, was the same and identical person as the John C. Jones, who, together with his wife, executed the warranty deed recorded in Deed Record "M", page 467 of said records, (both deeds conveying the N $\frac{1}{2}$ SE $\frac{1}{4}$ and NE $\frac{1}{2}$ SW $\frac{1}{4}$ of Sec. 31-74-29), the true and correct name of said Jones, being Jehu C. Jones. The statements in this paragraph being made upon reliable information and belief, and which are true as I verily believe.

(2) That James W. Hampton, grantee in the Warranty Deed recorded in Deed Record 2, page 585 of said records was the same and identical person as the J.W. Hampton, who, together with his wife, executed the warranty deed recorded in Deed Record 17, page 584 of said records (both deeds conveying the N $\frac{1}{2}$ SE $\frac{1}{4}$ and NE $\frac{1}{2}$ SW $\frac{1}{4}$ of Sec. 31-74-29), the full name of said Hampton, being James W. Hampton.

(3) That T.S. Vincent, grantee in the Warranty Deed recorded in Deed Record 17, page 584 of said records was the same and identical person as the T.L. Vincent, who, together with his wife, executed the warranty deed recorded in Deed Record 17, page 593 of said records, the first deed conveying the N $\frac{1}{2}$ SE $\frac{1}{4}$ and NE $\frac{1}{2}$ SW $\frac{1}{4}$ of Sec 31-74-29 and the last described deed conveying the NE $\frac{1}{2}$ SW $\frac{1}{4}$ and NW $\frac{1}{2}$ SE $\frac{1}{4}$ of Sec. 31-74-29, the correct name of said Vincent being T.L. Vincent. That I was the grantee in the last described deed from T.L. Vincent and wife.

I further state that I am in no way interested in the title to the land above described, but make this affidavit at the request of the present owner thereof for the purpose of establishing of record the facts as herein stated.
