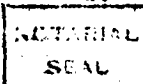

STATE OF IOWA, Union County SS: I, Fred W. Reinig of said county and

state on oath do depose and say that I have been of resident of said county for more than
15 years last past; during which time I have been more or less familiar with the title to
the land hereinafter described in the adjoining county of Madison and State of Iowa.

That I was well and personally acquainted with G.A. Swanson named as grantee
in the deed from B.L. Shrift, and wife, dated April 19, 1911, and filed in Madison county, Iowa
April 22, 1911, in deed record 50, page 132, conveying an undivided two-thirds of the NE $\frac{1}{4}$ NE $\frac{1}{4}$
of Sec. 10 Twp. 74 N. Rng 28, Madison county, Iowa; and with G.A. Swanson named as grantee in
that deed made by C.G. Bertholf, a widower, and Elwood F. Bertholf, and wife, dated March 2nd,
1911, and recorded March 8, 1911, in deed record 50, at page 115 of the records of Madison county
Iowa, conveying an undivided two-thirds interest in the N $\frac{1}{2}$ SE $\frac{1}{4}$ Sec. 10, except the SW $\frac{1}{4}$ NE $\frac{1}{4}$ SE $\frac{1}{4}$

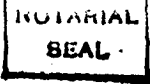
and excepting the following tract, to-wit; Commencing at a point 40 rods east of the southwest corner of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec.10, running thence north 17 $\frac{1}{2}$ rods, thence east 45 rods, thence south 17 $\frac{1}{2}$ rods, thence ^{WEST} 45 rods to beginning; and the S $\frac{1}{2}$ NE $\frac{1}{4}$ Sec.10, all in Twp.74 N.Rng.28, west of the 5th P.M., Madison county, Iowa; and know of my own knowledge that the said G.A.Swanson named as grantee in the two deeds above described is the same and identical person as the Gustaf A.Swanson, who with his wife, Ruby Swanson, who executed that certain deed to Erick S.Sellin, which deed was dated Feb.19, 1914, and filed Feb.21, 1914 in Madison county, Iowa and recorded in deed record 52, at page 354 thereof.

That I was well and personally acquainted with E.S.Sellin named as grantee in the two deeds first above mentioned and recorded in Madison county, Iowa, in deed record 50, pages 115 and 132 thereof, and was conveyed an undivided one-third interest in the land described therein, and know of my own knowledge that he was the same an identical person as Erick S.Sellin named as grantee in the deed from Gustaf A.Swanson, and wife, above mentioned which deed was recorded in deed record 52, at page 354 of the records of Madison county, Iowa.

I further depose and say that I have no interest in the lands described above and make this affidavit for the purpose of setting forth the facts contained above.
